WHEREAS, Patrick Quinton led PDC in its efforts in redevelopment, including the acquisition of the United States Post Office site, the development of the Portland Mercado, and investment in the Lents Town Center;

WHEREAS, Patrick Quinton has provided dynamic, forward-thinking, and thoughtful counsel to the PDC Leadership Team, the PDC Board of Commissioners (“Board”), and to all PDC employees who sought his advice as PDC conducted its work on behalf of the citizens of Portland;

WHEREAS, Patrick Quinton has served on the boards of Greater Portland Inc, Oregon Story Board, and Portland Business Alliance;

WHEREAS, Patrick Quinton has brought a tremendous sense of professionalism and collaboration to PDC where he is highly regarded by his colleagues;

WHEREAS, Patrick Quinton has earned the admiration and respect of the PDC Board and staff for his dedication, enthusiasm, and hard work;


WHEREAS, Patrick Quinton has ably represented the City as Executive Director of PDC here in Oregon, across the nation, and internationally; and


