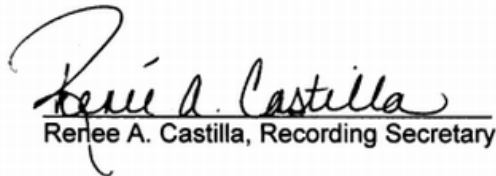

**WHEREAS**, the PDC Loan Committee functions as the RLF Loan Board.

**NOW, THEREFORE BE IT RESOLVED** that in accordance with Part II J. 2. of the EDA RLF Standard Terms and Conditions, dated September 30, 2002, and the Code of Federal Regulations at 13 CFR Part 308.9, the PDC Board of Commissioners hereby certifies that PDC has complied with the terms of EDA Grant #07-39-2093, for the federal fiscal year ending September 30, 2008; and

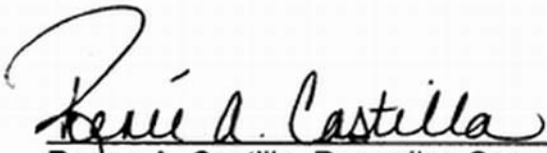
