**RESOLUTION NO. 6742**

**CREATING A NEW POSITION ON THE RIVER DISTRICT URBAN  
RENEWAL ADVISORY COMMITTEE TO REPRESENT PORTLAND  
PUBLIC SCHOOLS, AND APPOINTING MS. C.J. SYLVESTER TO FILL  
SUCH POSITION.**

**WHEREAS**, the PDC Board of Commissioners (“Board”) recognizes and values the contribution that existing community groups and individuals provide in developing and implementing urban renewal plans;

**WHEREAS**, an Urban Renewal Advisory Committee (“URAC”) can provide valuable feedback to the Board and project staff on short and long term implementation plans and budgets, and assistance to staff in identifying and involving other community stakeholders in urban renewal projects;

**WHEREAS**, on June 25, 2008 the Board adopted Resolution No. 6611 which established a Cooperative Agreement with Portland Public Schools to become a Taxing Jurisdiction Partner on URACs whose urban renewal plans are amended or created;

**WHEREAS**, on July 9, 2008, the Board amended PDC’s URAC Policy to create the Taxing Jurisdiction Partners member category to allow these partners to have voting representatives on URACs when urban renewal plans are amended or new urban renewal plans are created (Resolution No. 6614);

**WHEREAS**, on July 9, 2008, the Board adopted Resolution 6615 which established the River District Urban Renewal Advisory Committee; and

**WHEREAS**, on November 12, 2008, the Board adopted Resolution No. 6647 which appointed 15 individuals to serve as members of the River District URAC.


**NOW, THEREFORE, BE IT RESOLVED** that a new position is hereby created on the River District URAC to represent a Taxing Jurisdiction Partner;

**BE IT FURTHER RESOLVED** that Portland Public Schools is designated to fill the new Taxing Jurisdiction Partner position;

**BE IT FURTHER RESOLVED** that C.J. Sylvester is hereby appointed to River District URAC as a representative of Portland Public Schools for a term beginning on October 14, 2009 and ending on June 30, 2012; and

**BE IT FURTHER RE SOLVED** that this resolution shall become effective immediately upon its adoption.
