**APPOINT GUS BAUM TO THE RIVER DISTRICT URBAN
RENEWAL ADVISORY COMMITTEE AS A COMMUNITY

WHEREAS, the PDC Board of Commissioners (“Board”) recognizes and values the contribution that existing community groups and individuals provide in developing and implementing urban renewal plans;

WHEREAS, an Urban Renewal Advisory Committee (“URAC”) can provide valuable feedback to the Board and project staff on short and long term implementation plans and budgets, and assistance to staff in identifying and involving other community stakeholders in urban renewal projects;


WHEREAS, on July 9, 2009, the Board adopted Resolution 6615 which established the River District URAC and on November 12, 2009, the Board adopted Resolution No. 6647 which appointed 15 individuals to serve as members of the River District URAC; and

WHEREAS, the Pacific Northwest College of Art has been represented on the River District URAC since its creation;

NOW, THEREFORE, BE IT RESOLVED that Gus Baum be appointed to the River District URAC as a community partner representing the Pacific Northwest College of Arts for a term beginning October 13, 2010 and ending June 30, 2013;

BE IT FURTHER RESOLVED that this resolution shall become effective immediately upon its adoption.


