APPOINT MS. SIA SELLU AND REAPPOINT MS. RACHEL CUNNINGHAM TO THE LENTS TOWN CENTER URBAN RENEWAL ADVISORY AREA COMMITTEE

WHEREAS, the PDC Board of Commissioners ("Board") recognizes and values the contribution of community organizations and individuals in developing and implementing urban renewal plans;

WHEREAS, on June 14, 2006, the Board established the Lents Town Center Urban Renewal Area Advisory Committee ("LTC URAC") (Resolution No. 6367);

WHEREAS, on June 8, 2011 the Board amended the Urban Renewal Advisory Committee Policy (Resolution No. 6886), allowing members to serve for terms of up to three years;

WHEREAS, the Board desires to grant one-year reappointments for members of the LTC URAC whose terms expire on June 30, 2011, and grant three-year appointments for new members whose terms will begin July 1, 2011;

NOW, THEREFORE, BE IT RESOLVED that Ms. Sia Sellu is hereby appointed to the LTC URAC as an organizational member representing the Lents Neighborhood Association for a term beginning July 1, 2011, and ending June 30, 2014.;

NOW, THEREFORE, BE IT RESOLVED that Ms. Rachel Cunningham is hereby reappointed to the LTC URAC as a Taxing Jurisdiction Partner member representing Multnomah County for a term beginning July 1, 2011, and ending June 30, 2012.; and

BE IT FURTHER RESOLVED that this resolution shall become effective immediately upon its adoption.
