8. Action Item: Resolution 7440 - Adopting Budget Amendment No. 1 for the Fiscal Year Beginning July 1, 2021, and Ending June 30, 2022; and Making Appropriations

Prosper Portland staff and guest presenting this item: Tony Barnes, Finance Manager



With this action, the Prosper Portland Board amended the current fiscal year (FY) 2021-22 budget as follows:

- Adjusted beginning fund balances to reflect actual FY 2020-21 year-end balances;
- Added American Rescue Plan (ARP) budget appropriations of \$3,000,000 based on the allocation from the City of Portland (City) for small business and business corridor support for FY 2021-22;
- Added City Council's fall budget revision for allocation of \$2,050,000 in one-time General Funds to support economic development strategic planning and community grants;
- Updated project, program, and administrative expenditures that are underway for committed carryover of funds that did not spend in the FY 2020-21; and
- Updated Affordable Housing Set Aside budgets based on estimated timing of expenditures from the City Housing Bureau.

Mr. Barnes explained the purpose for the revisions, including but not limited to the updated, 1.) forecast estimates of current year activity, 2.) budget from Portland Housing Bureau and 3.) ARP and fall general fund budget revisions.

Mr. Barnes continued by providing a summary of total resources and forecasted spend-down of resources. Additionally, Mr. Barnes reviewed increases and decreases by business line and a one-time allocation from City Council.

Chair Cruz called for a motion to approve Resolution No. 7440; Commissioner Myers moved and Commissioner Stoudamire Wesley seconded the motion.

# 9. Information Item: Update on the Lents Town Center Phase 2 Redevelopment Project

Prosper Portland staff presenting this item: Karl Dinkelspiel, Development Manager

Mr. Dinkelspiel reviewed the recent history of Prosper Portland's work in the Lents Town Center beginning with the approval of the Five-Year Lents Action Plan in May 2014, which resulted in the following completed projects for Phase I: 1.) Woodie Guthrie, 2.) Asian Health & Science Service Center, 3.) Lents Commons, and 4.) Oliver Station.

Mr. Dinkelspiel stated Phase 2 outreach began in November 2016 and includes, 1.) 92<sup>nd</sup> & Harold (92/H), 2.) Block F, 3.) Bakery Blocks, and 4.) a Public Plaza. Mr. Dinkelspiel reviewed the 92/H redevelopment terms in detail regarding the 1.) Disposition and Development Agreement and 2.) Ground Lease.

Due to the COVID-19 pandemic, development progress has been impacted and it is anticipated the Bakery Blocks development will begin in early 2022 and 92H in 2023-2024.

Mr. Dinkelspiel invited Robert Gibson to testify.

Robert Gibson, Vice President Development, Palindrome Communities, provided overall project status and accomplishments of the multiple projects they have been working on over the past two years.



# 10. Information Item: Update on the Construction Business and Workforce Equity Policy

Prosper Portland staff presenting this item:

John Cardenas, Construction Business & Workforce Equity Program Manager

Mr. Cardenas provided background on the Construction Business & Workforce Equity (CBWE) Policy which was adopted by the Prosper Portland Board in April 2021. Most notably, the CBWE Policy 1.) increased equity goals for certified Business Inclusion Diversity firms, 2.) created a construction equity fund, and 3.) added anti-harassment culture change requirement. The Prosper Portland Board also directed staff to conduct further conversations and analysis about whether to include a Community Workforce Agreement (CWA) into the CBWE Policy.

Mr. Cardenas noted that since April 2021, staff has 1.) solicited input from both business and workforce partners, 2.) reviewed investment threshold implications, and 3.) researched best practices from across the region.

As a result of this work, Mr. Cardenas pointed out there was a lack of consensus around thresholds to incorporate a CWA into the CBWE Policy and recommended not making any formal changes to the CBWE Policy at this time.
