# Information Item: Tax Supervising and Conservation Commission (TSCC) Public Hearing on and Certification of the Fiscal Year 2021-22 Approved Budget

8. Action Item: Resolution 7453 - Adopting the Annual Budget of Prosper Portland for the Fiscal Year Beginning July 1, 2022, and Ending June 30, 2023; and Making Appropriations

With this action, the Prosper Portland Board formally adopted Prosper Portland's fiscal year (FY) 2022-23 Recommended Budget, effective July 1, 2022. The Prosper Portland Board's adoption of the FY 2022-23 Recommended Budget represents the final phase of the FY 2022-23 budget process, which began in November 2021.

Mr. Barnes reviewed the budget timeline, council actions, and compared the requested and approved budget items. Mr. Barnes continued by summarizing the changes to the budget resources and requirements.

Chair Cruz called for a motion to approve Resolution 7453; Commissioner Platt moved and Commissioner Rodriguez seconded the motion.

 Action Item: Resolution 7454 - Authorizing a Guaranteed Maximum Price Agreement with Northwest Infrastructure LLC for Soil Remediation and Site Work at the United States Postal Service Property at 715 NW Hoyt Street

Commissioner Myers read a statement recusing himself from the discussion.

With this action, the Prosper Portland Board authorized a guaranteed maximum price contract with Northwest Infrastructure LLC in an amount not to exceed \$666,420 to complete necessary site work, including soils remediation, reconfiguration of parking and loading accessways, and demolition of an



electrical utility vault on the Prosper Portland-owned property at 715 NW Hoyt Street in the River District tax increment finance district. The action further provides for an owner's-controlled contingency of \$100,000 (15%) to be utilized in the event of unforeseen conditions or other appropriate circumstances. The timely completion of these site preparation activities is necessary for the initial phases of the Broadway Corridor redevelopment.

Ms. Harpole reviewed the critical path to site readiness and sitework preparation for demolition. Ms. Harpole stated 54.4 percent construction dollars had been earned by certified Minority Business Enterprises and 43.8 percent of hours worked by Black, Indigenous, and People of Color thus far.

Ms. Harpole continued by outlining the phasing of site development as well as reviewing public funding and financing of site requirements.

Chair Cruz called for a motion to approve Resolution 7454; Commissioner Stoudamire Wesley moved and Commissioner Platt seconded the motion.

# 10. Action Item: Resolution 7455 – Adopting the First Amendment to the Gateway Regional Center Urban Renewal Plan

With this action, the Prosper Portland Board amended the Gateway Regional Center Urban Renewal Plan by removing the last date to issue debt. As a result, Prosper Portland, in partnership with the City of Portland Debt Management Office, will be able to access financial resources to support work in Gateway beyond June 30, 2022.

Mr. Barnes provided background information on debt issuance noting approximately \$91,000,000 of \$164,200,000 in approved maximum indebtedness had been issued to date. With the Prosper Portland Board's approval, this action will access an additional estimated \$50,000,000 total over the next 10 to 12 years.

Mr. Barnes stated the existing bonds will be paid off by year 2037 rather than 2032. Mr. Barnes continued by acknowledging and addressing the potential financial impact on the David Douglas School District (DDSD) noting the resolution commits to a partnership with DDSD committing Tax Increment Finance eligible investments.

Mr. Devalcourt shared several Gateway successes and challenges to date.

Mr. Devalcourt reviewed the Gateway Five-Year Action Plan (Action Plan) and remaining priorities along with community and business outreach. He then reviewed future Action Plan timeline beginning June 2022 through April 2023.

Chair Cruz called forward guests to testify:

Arlene Kimura, Hazelwood Neighborhood Association was part of the original Opportunity Gateway Process and many subsequent engagement efforts. Ms. Kimura noted the difficulty of redevelopment in Gateway and noted the additional TIF resources will help.



Nidal Kahl, Gateway Area Business Association, acquired property during the recession and has observed the transition. Mr. Kahl was supportive of the Prosper Portland Board action noting it will yield resources to continue to support the Gateway community.

Chair Cruz called for a motion to approve Resolution 7455; Commissioner Platt moved and Commissioner Stoudamire Wesley seconded the motion.
