10. Action Item: Resolution 7461 - Authorizing a Guaranteed Maximum Price Agreement with Northwest Demolition and Dismantling, Inc. for Demolition of Structures located on the United States Postal Service Property at 715 NW Hoyt Street

Prosper Portland staff presenting this item: Sarah Harpole, Project Manager I

With this action, the Prosper Portland Board authorized a guaranteed maximum price contract with Northwest Demolition and Dismantling, Inc. in an amount not to exceed \$30,417,615 to demolish the former United States Postal Service Processing and Distribution Center facility located on the Prosper Portland-owned property 715 NW Hoyt Street in the River District tax increment finance (TIF) district. The action further provides for an owner's-controlled contingency of \$2,000,000 to be utilized in the event of unforeseen conditions or other appropriate circumstances. The timely completion of these site preparation activities is necessary for the initial phases of the Broadway Corridor redevelopment.

Ms. Harpole provided an overview of the demolition contract and summary of terms and reviewed the scope of the project. Ms. Harpole noted Prosper Portland is honoring the spirit of the community benefits agreement discussed with the Healthy Communities Coalition.

Ms. Harpole explained cost increases in the contract are due to inflation, the inability to crush and reuse concrete, and other unforeseen conditions.

Ms. Harpole reviewed budget sources utilized including the River District TIF, General Fund and temporary utilization of Program Income/Unrestricted Funds.

Ms. Harpole shared potential project risks (i.e., unforeseen conditions like rain and subsequent water management, the receipt of recycled-material credit). Lastly, Ms. Harpole summarized next steps.

Commissioner Myers recused himself from the discussion and subsequent vote.

Chair Cruz invited forth guest testimony.

Chad Hoffart, Northwest Demolition and Dismantling, Inc, (NWDD) reiterated the NNWD team is highly qualified to do the work.

Ashley Henry and Webster Moreland, Raimore Construction, noted they contract regularly with smaller minority businesses in Portland and are excited for the opportunity.

Chair Cruz called for a motion to approve Resolution No. 7461; Commissioner Stoudamire Wesley moved and Commissioner Rodriguez seconded the motion.

11. Action Item: Resolution 7462 - Authorizing an Intergovernmental Agreement with the Portland Housing Bureau for Implementation of the Affordable Housing Set-Aside Policy and Administration of the Economic Opportunity Initiative Program

With this action the Prosper Portland Board authorized the Executive Director to execute an intergovernmental agreement with the City of Portland Housing Bureau (PHB) for PHB's implementation of housing rehabilitation, finance, and development in tax increment finance (TIF) districts; and transfer of federal Community Development Block Grant (CDBG) and CDBG CARES Act resources from PHB to Prosper Portland for the purpose of operating and administering the Economic Opportunity Initiative (EOI) program for fiscal year 2022-23.

Mr. Barnes provided an overview of the agreement including joint project roles and responsibilities, housing set-aside and related EOI CDBG invoicing and funding.

Mr. Barnes reviewed the status of the housing set-aside, and actual and planned spending compared to the 2015 forecast.

Mr. Tschabold spoke to the partnership between Prosper Portland and PHB, provided an overview of PHB's main lines of business and reviewed PHB's budget.

Mr. Tschabold reviewed rental housing production from 2015-2021 and projects opening for years 2022 and 2023.

Mr. Tschabold summarized PHB's displacement prevention, including emergency rent assistance, and critical home repairs. During COVID-19, PHB stood up a legal defense for eviction.

Mr. Tschabold concluded by sharing upcoming new initiatives.

Chair Cruz called for a motion to approve Resolution No. 7462; Commissioner Myers moved and Commissioner Platt seconded the motion.
