6. Action Item: Resolution 7476 – Authorizing a Construction Loan and Purchase and Sale Agreement with Home Forward for the Renovation and Acquisition of Commercial Retail Space at 1103 - 1121 SW Harvey Milk Street in the River District Urban Renewal Area and Authorizing an Exemption from the Prosper Portland Green Building Policy

With this action, the Prosper Portland Board authorized the Executive Director to enter into two agreements with Home Forward to support the purchase and development of real property located at 1103 - 1121 SW Harvey Milk Street (Fairfield Building) in the River District Tax Increment Finance (TIF) District.

Prosper Portland will invest \$1,900,000 in federal American Rescue Plan Phase 2 funding and \$700,000 in River District TIF funding to acquire and improve a 3,000 square foot ground floor retail condominium space that will be enrolled in the agency's Affordable Commercial Tenanting Program. The remainder of the Fairfield Building will be redeveloped by Home Forward as an affordable housing project.

This action also authorizes an exemption from the Prosper Portland Green Building Policy and will instead apply the Oregon Housing and Community Services' (OHCS) Sustainable Development Practices to both the residential and the commercial portions of the project.

Ms. Abuaf reviewed the site and noted multiple partners and funding sources.



Ms. Abuaf provided a brief history of the Fairfield Building noting the Portland Housing Bureau (PHB) purchased the building from Prosper Portland in 2010. The Fairfield Building has been managed by Home Forward since 2017. Ms. Abuaf stated Prosper Portland was approached by PHB and City Council to assist and administer the commercial portion of the Fairfield Building.

Mr. Kerosky provided an overview of the project including upgrades, replacements, and improvements to modernize and increase safety and livability as well as funding and the project schedule.

Mr. Kerosky discussed the exemption request for the Green Building Policy, noting that applying the OHCS sustainability standards are expected to result in reduction in utility costs by 15% per year over current usage and 43% for energy usage per square foot. All future tenant improvements would be subject to the Green Building Policy requirements.

Chair Cruz inquired about the risk of potential cost increases. Mr. Kerosky noted that Prosper Portland's commitment is capped at \$1,900,000.

Chair Cruz called forward invited testimony.

Amanda Saul, Assistant Director, Home forward, addressed Chair Cruz's concern noting they have an experienced team who is very familiar with buildings that require seismic upgrades and employ a 10% construction contingency on both the residential and commercial side of the project.

Chair Cruz called for a motion to approve Resolution No. 7476; Commissioner Myers moved and Commissioner Stoudamire Wesley seconded the motion.
