6. Action Item: Resolution 7481 – Endorsing Advance Portland: A Call to Action for Inclusive Economic Development, and Recommending Adoption by Portland City Council

With this action, the Prosper Portland Board endorsed a City-wide inclusive economic development strategy known as Advance Portland: A Call to Action for Inclusive Economic Development (Advance Portland) and recommended adoption by Portland City Council. Advance Portland identifies key policies, approaches, partnerships, and investments necessary to achieve inclusive, sustainable economic growth goals in the next five years through the lens of racial equity and climate action.

Mr. Flaherty-Betin stated achieving the objectives of Advance Portland will require connectivity with the City of Portland and regional initiatives such as: the Workforce Development Plan, Comprehensive Economic Development Plan, A Home for Everyone, and Cradle to Career, with the consideration of fundamental preconditions for growth around houselessness, livability, community safety and the public education system.

Mr. Flaherty-Betin noted the strategy is built around how to get the economics right, to have jobs for individuals receiving job training, help for entrepreneurial businesses, and access to capital and wealth to support objectives like home ownership, and supporting the tax base that enables the above.



Mr. Flaherty-Betin identified the goal of Advance Portland - Inclusive growth through market-based interventions that advance competitiveness, racial equity, and climate action.

Mr. Flaherty-Betin continued by reviewing the City of Portland's current strengths (i.e., home to world-class airport and export infrastructure, strong entrepreneurial ecosystem, national leaders in climate action and land use). Mr. Flaherty-Betin followed by stating challenges facing Portland which arose from a failure to equitably manage growth, for example, 1.) high paying occupations and business owners are disproportionally white, 2.) the City of Portland business growth rate and employment growth rate lag other regions, and 3.) existing anti-business sentiment.

Mr. Flaherty-Betin listed the four mutual reinforcing values of the strategy:

- Further Racial Equity and Inclusion
- Advance Climate Action
- Build Effective Institutions and Partnerships
- Embrace and Manage Growth

Mr. Flaherty-Betin shared grounded in the above values are the following four objectives to which Ms. Neal, Mr. Smith, Ms. Abuaf and Mr. Flaherty Betin briefly shared:

- Propel Inclusive Economic Growth and Innovation in Clusters Ms. Neal provided a few examples to achieve the objective
- Promote Equitable Wealth Creation Mr. Smith provided goals and example of how to close the gap
- Foster a Vibrant City Center Ms. Abuaf reviewed short- and long-term actions
- Connect Portlanders to High-Quality Jobs in Future-Ready Sectors Mr. Flaherty-Betin shared desired outcomes and indicators

Ms. Flaherty-Betin reviewed next steps.

Commissioner Platt noted it is a tough time for businesses looking to borrow.

Chair Cruz shared his concerns about cross-bureau initiatives.

Commissioner Platt inquired abouts next step if City Council votes yes to which Mr. Flaherty-Betin responded the team will provide both the Prosper Portland and City Council with immediate actionable items.

Chair Cruz called for a motion to approve Resolution No. 7481, Commissioner Myers moved, and Commissioner Rodriguez seconded the motion.

7. Information Item: Update on the Fiscal Year 2023-24 Budget Development Process Prosper Portland staff presenting this item: Tony Barnes, Finance Manger

Staff provided an update on the fiscal year (FY) 2023-24 Proposed Budget (Proposed Budget).

Mr. Barnes recapped the development process and identified next steps explaining after Prosper Portland Board input and direction, staff will finalize the Proposed Budget and present to the Portland City Council (City Council), acting as the Prosper Portland Budget Committee, on May 10, 2023. City



Council is expected to approve the Proposed Budget on May 18, 2023. Staff will seek the Prosper Portland Board's adoption of the City Council-approved Proposed Budget at its June 21, 2023, meeting.

Ms. Abuaf shared that Prosper Portland staff engaged with various Tax Increment Finance (TIF) district partners, including but not exclusive to, South Portland Neighborhood Association, Go Lloyd, N/NE Action Plan Leadership Committee, to check in on priorities and receive feedback and input.

Mr. Barnes provided listed, by line-item, one-time funding approved by City Council earlier in the day.

Commissioner Rodriguez stated Old Town requires a purposeful strategy and in-depth discussion considering the available dollars.

Executive Director Branam noted Prosper Portland is in active conversations and will share with the Board on the development of the conversations at future briefings.

There being no further business, Chair Cruz adjourned the Prosper Portland Board meeting at approximately 4:40 p.m.
