7. Action Item: Resolution 7485 - Adopting the Annual Budget of Prosper Portland for the Fiscal Year Beginning July 1, 2023, and Ending June 30, 2024; and Making Appropriations

Prosper Portland staff presenting this item: Tony Barnes, Finance Manager

With this action, the Prosper Portland Board formally adopted Prosper Portland's FY 2023-24 Recommended Budget, effective July 1, 2023. The Prosper Portland Board's adoption of the FY 2023-24 Recommended Budget represents the final phase of the FY 2023-24 budget process, which began in November 2022.

Mr. Barnes reviewed the budget timeline, City Council actions, and compared the requested and approved budget items. Mr. Barnes continued by summarizing the changes to the budget resources and requirements.

Chair Cruz called for a motion to approve Resolution 7485; Commissioner Myers moved and Commissioner Stoudamire Wesley seconded the motion.

8. Action Item: Resolution 7486 - Authorizing an Exception to Sublease Guidelines at Alberta Commons for a Sublease with Micro Enterprise Services of Oregon

Prosper Portland staff presenting this item: Kay Little, Asset & Investment Manager

With this action, the Prosper Portland Board authorized execution of a sublease agreement (Sublease) with Microenterprise Services of Oregon (MESO) at Prosper Portland master leased space at Alberta Commons, at a base rate lower than would otherwise be required by the applicable sublease guidelines.

The Sublease will allow Prosper Portland to partner with MESO to continue to operate a Makers Market and Retail Incubator that will also provide technical assistance support and hands-on experience to MESO clients and other underrepresented entrepreneurs. Since the proposed starting base lease rate is set at \$14.00 per square foot, which is below the Prosper Portland Board-approved minimum base lease rate of \$18.00 per square foot, staff are seeking Prosper Portland Board approval.

Mr. Little reviewed the history of Alberta Commons, described the parameters of the space, and provided a summary of the project.



Mr. Little stated MESO will use the space to create opportunities for Black, Indigenous, and People of Color entrepreneurs to receive hands on education - learning merchandising and branding skills, as well as a venue to sell their wares with a low overhead.

Mr. Little reviewed the proposed sublease terms and the strategic alignment with Prosper Portland Financial Stability Plan Update.

Chair Cruz invited forth guest testimony:

Cobi Lewis, MESO, Executive Director, thanked the Prosper Board and staff for support received since 2022, stating it has made a huge impact.

Chair Cruz called for a motion to approve Resolution 7486; Commissioner Stoudamire Wesley moved and Commissioner Rodriguez seconded the motion.
