 Action Item: Resolution 7517 - Accepting and Approving the Annual Comprehensive Financial Report for Fiscal Year 2022-23 and Accepting the Communication with Those Charged with Governance

With this action, the Prosper Portland Board, acting as the Prosper Portland Audit Committee, accepted and approved the completed Annual Comprehensive Financial Report for the fiscal year ended June 30, 2023, and accepted the Communication With Those Charged With Governance Letter from accounting firm Moss Adams, LLP (Moss Adams).

Ms. Rede outlined the Auditor's Office involvement with Prosper Portland's financial overview.

Mr. Simovic shared the services provided by Moss Adams and the following outcomes:

10. Action Item: Resolution 7518 - Approving the Terms of a Commercial Property Redevelopment Loan and a Thriving Small Business Loan to Creative Homies, LLC, in an Aggregate Amount Not to Exceed \$700,000, for to Finance Construction of, and Working Capital Needs of, a Redevelopment Project Located at 433 NW 4th Avenue in the Downtown Waterfront Tax Increment Finance District

Prosper Portland Staff presenting this item: Carlos Moreno, Senior Business Finance Officer

With this action, the Prosper Portland Board authorized the Executive Director to make a \$147,395 Commercial Property Redevelopment Loan, and a \$552,605 Thriving Small Business loan, to Creative Homies, LLC, for construction and operations of a mixed-use venue at the 20,000 square foot Horizon Building located at 433 NW 4th Avenue, in the Downtown Waterfront TIF District.



Mr. Moreno provided information regarding the site and the borrower's vision. Mr. Moreno continued by sharing the project financials.

Mr. Moreno reviewed key loan terms and highlighted the positive equity impact in alignment with the Advance Portland.

Commissioner Cruz requested a future conversation to discuss Prosper Portland's underwriting practices.

Chair Cruz invited forth guest testimony.

Adewale Agboola, Creative Homies, co-owner, expressed his desire to create generational wealth by purchasing rather than renting the building. He declared there is much community support proven by his winning the Pitch Black event.

Chair Cruz called for a motion to approve Resolution No. 7518, Commissioner Myers moved, and Commissioner Slick seconded the motion.

11. Action Item: Resolution 7519 and 7520 - Authorizing the Terms of a Development Agreement Relating to the Design and Construction of a Private Mixed-Use Development and Public Infrastructure at and Near NE 102nd Avenue and Pacific Street in the Gateway Tax Increment Finance District; Authorizing an Intergovernmental Agreement with the City of Portland Bureau of Transportation to Fund Infrastructure Improvements in the Gateway Tax Increment Finance District

Prosper Portland and Guests presenting this item: Brian Moore, Development Manager Joel Devalcourt, Project Manager I

With these actions, the Prosper Portland Board approved i) a Development Agreement with Modomi Gateway LLC and David Douglas School District (DDSD) that provides \$2,849,101 for development of a mixed-use mixed-income redevelopment project (Project), and ii) an Intergovernmental Agreement (IGA) with the City of Portland Bureau of Transportation in the amount of \$603,000.

These actions will provide funding for critical infrastructure improvements within the Gateway Transit Center area of the Gateway Tax Increment Finance District; introduce a network of streets improving neighborhood connectivity; satisfy Prosper Portland's obligations to DDSD per Prosper Portland Board Resolution No. 7455 (June 7, 2022); and advance redevelopment of a vacant superblock property into an innovative project called "Modomi Gateway" at NE 102nd Avenue and Pacific Street providing at least 216 units of middle-income housing.

Mr. Moore described how the action aligns with the Advance Portland program by incorporating innovative housing, creating new economic opportunities, and attracting a new housing construction model i.e., modular construction.



Mr. Devalcourt discussed details of the development agreement with Modomi and the intergovernmental agreement between Prosper Portland and the Portland Bureau of Transportation. Mr. Devalcourt concluded by reviewing the infrastructure funding.

Chair Cruz invited forth guest testimony.

Tom Cody, Modomi, shared the company's current success in Bend and highlighted the aim to build middle income housing in Gateway.

Chair Cruz called for a motion to approve Resolution No. 7519, Commissioner Myers moved, and Commissioner Alvarez seconded the motion.
