6. Action Item: Resolution 7614 - Authorizing an Amendment to a Personal Services Contract with Workplace Change, LLC

7. Action Item: Resolution 7615 - Adopting a Comprehensive Financial Investment and Real Estate Policy

Prosper Portland staff presenting this item: Tony Barnes, Chief Financial Officer Will Thier, Development Manager

With this action, the Board rescinded the Financial Investment Policy, multiple property-specific leasing guidelines, and three real estate policies, and adopted a combined Financial Investment and Real Estate Policy (FINREP or Policy) that provides a single comprehensive approach to Prosper Portland's investment activities.

Staff stated that the goal of adopting this Policy is to provide a strategic, transparent, consistent, and risk-balanced framework to guide Prosper Portland's investment of public resources, and to ensure full compliance with local, state, and federal laws, Prosper Portland's Charter, relevant Tax Increment



Finance (TIF) District Plans, and Prosper Portland's other Board-adopted policies. The Policy, as adopted, will guide Prosper Portland's (a) acquisition, ownership, operation, and disposition of real property; (b) lending and grant-making activities; (c) use of Program Income and other resources and assets; and (d) management of TIF District assets and income.

Mr. Barnes provided context on past policy actions related to investment and real estate and introduced new updates.

Mr. Thier reviewed policy actions dating back to 2010, noting more than seven subsequent updates. He explained the opportunity to consolidate these into a single policy framework covering four major areas with detailed guidance. Updates include standardizing Executive Director delegations and clarifying the Committee for Accountability of Finances and Equity thresholds.

Mr. Thier also outlined three new investment categories that will serve as a framework to evaluate and compare future investments.

Mr. Barnes reviewed the new Fund Management section, which organizes funds into four categories:

- Strategic Investment Fund (SIF)
- Active & Sunsetting TIF Districts
- Terminated TIF Districts
- Citywide Investments

Chair Cruz called for a motion to approve Resolutions No. 7615, Commissioner Slick moved, and Commissioner Hagins seconded the motion.

8. Action Item: Resolution 7616 - Approving the Terms of a Loan to the Historic Portland Public Market Foundation dba James Beard Public Market

Prosper Portland staff presenting this item: Kay Little, Development Manager Sarah King, Project Manager I

With this action, the Board authorized the Executive Director to provide a non-programmatic, forgivable commercial property loan (Loan) to Historic Portland Public Market Foundation, dba James Beard Public Market (JBPM) in an amount of up to \$2,683,125 for the major renovation of two commercial buildings in the Westside Tax Increment Financing (TIF) District, into the James Beard Public Market.

Ms. King reviewed the mission of JBPM, noting its role in providing regional benefits.. She provided an overview of project locations, venue space, expected tourism impact, and the unique designation as the only site in the U.S. with rights to use the name. Ms. King also outlined the project timeline from building acquisition through completion.

Mr. Little presented details on the loan structure, including sources and uses, and terms of loan forgiveness. He noted that the Oregon State Legislature approved \$10 million in lottery bond funding in June 2025.

Chair Cruz invited forth guest testimony.



Jessica Elkan, JBPM Executive Director, shared that this was a long-awaited vision for Portland, emphasizing Prosper Portland's early investment as critical to reaching this milestone. She highlighted the project's core focus on economic development and entrepreneurship, noting plans to support 40 new small businesses and showcase thousands of Oregon products. She also described the wrap-around support services that will be provided to vendors.

Chair Cruz called for a motion to approve Resolution No. 7616, Commissioner Alvarez moved, and Commissioner Hagins seconded the motion.

9. Action Item: Resolution 7617 - Approving Reimagine Oregon Economic Opportunity Investment Fund Grant Awards

Prosper Portland staff presenting this item: Chabre Vickers, Director of Equity, Policy & Communications Victoria Schwoeffermann, Consultant

With this action, the Board approved \$1,350,000 in Reimagine Oregon Economic Opportunity Investment Fund Grants (Grants) to 25 Portland entities. Prosper Portland will provide grants to eligible entities within the city of Portland, including for-profit and nonprofit businesses, including social service organizations with a fiscal sponsor, with a focus on economic and business development for those disproportionately affected by cannabis prohibition. The Grants focus on three types of investments: i) Accelerating Business Growth and Entrepreneurship, ii) Building Community Wealth and Economic Empowerment, and iii) Creating Anchor Projects that Enhance Community Engagement and Collaboration.

Ms. Vickers provided context on Recreational Cannabis dollars, including the Reimagine Oregon history and transfer of fund management to Prosper Portland in 2023.

Ms. Vickers also reviewed fund goals, accomplishments from FY 2023–25 and the Spring 2024 Community Engagement Insight Report, and shared examples of grantee outcomes, such as staff hires enabled by funding, along with participant testimonials.

Chair Cruz called forth guest testimony.

Christina Lane, co- founder of Champions Barber Institute, stated that the fund has meant more than economic support, but economic justice. The fund wasn't performative it was real support and results occurred.

Jacquelyn Santa Lucia, Senior Development Manager at Adre, shared that one hundred percent of their grant funds went to local minority or women-owned small businesses, recirculating these funds back into our local economy.

Aryn Frazier, Executive Director at the Center for Black Excellence, stated that the grant was instrumental in supporting existing and expanded staff capacity, enabling the Center to contract with a software company to build a digital resource hub that centralizes nonprofit and for-profit student and family-centered resources.

Justice Rajee, Director of Reimagine Oregon Project, stated that they are looking forward to what this year's awardees will be able to do as the program continues to evolve, noting the program is a space for



innovation, learning, and showcasing what's possible with public funds, positive intention, focus and the genius in our community.

Ms. Schwoeffermann, consultant for Prosper Portland, provided an overview of Spring 2024 grantees and the launch of the program's second year, and reviewed the FY 2025–26 timeline.

Ms. Schwoeffermann highlighted three priority areas and anchor projects for engagement and collaboration. The program included two tracks (for-profit and nonprofit) with separate evaluation committees. Prosper Portland received a total of 270 applications for this round, with requests totally more than \$60 million. Staff recommended 25 grantees for awards totaling \$1.35 million.

Chair Cruz called for a motion to approve Resolutions No. 7617, Commissioner Alvarez moved, and Commissioner Hagins seconded the motion.

Chair Cruz reported on the national search process, noting Cornell emerged as the top candidate. At every stage of recruitment, stakeholders were impressed with his qualifications and leadership qualities.
