WHEREAS, the Prosper Portland Board of Commissioners (“Board”) recruitment process to fill the permanent position of Executive Director is not concluded;

WHEREAS, Shea Flaherty Betin is no longer serving as Interim Executive Director;

WHEREAS, to continue to assist in this transition period, the Prosper Portland Board desires to appoint another Interim Executive Director effective immediately, to act as Executive Director until the Prosper Portland Board approves the appointment of an Executive Director at the Prosper Portland Board’s discretion; and

WHEREAS, the Prosper Portland Board has selected Lisa Abuaf, Prosper Portland Director of Development and Investment, to serve as Interim Executive Director.

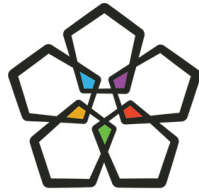
