RESOLUTION NO. 7623

NOMINATING MEMBERS TO THE 82nd AVENUE AREA TAX INCREMENT FINANCE DISTRICT COMMUNITY LEADERSHIP COMMITTEE AND RECOMMENDING CITY COUNCIL APPOINTMENT

WHEREAS, on April 26, 2023, Portland City Council through Resolution 37617 adopted Advance Portland: A Call to Action for Inclusive Economic Growth, a citywide strategy with an objective to foster neighborhood commercial districts;

WHEREAS, the strategy directed staff to return to City Council within 90 days of Advance Portland's approval to launch a TIF district exploration process, with early priority on East Portland (including 82nd Avenue) and concurrent focus on Central City;

WHEREAS, on June 28, 2023, through Resolution No. 37623, Portland City Council ("City Council") directed Prosper Portland and the Portland Housing Bureau to conduct an exploration, in partnership with community, of the use of Tax Increment Financing (TIF) as a tool for stabilization, equitable development and inclusive growth, as well as the potential creation of new TIF districts in East Portland and the Central City to advance these objectives;

WHEREAS, on August 28, 2024, through Resolution No. 7566, the Prosper Portland Board of Commissioners ("Board") approved the 82nd Avenue Area Tax Increment Finance ("TIF") District Plan and forwarded it to Portland City Council ("City Council") with a recommendation for adoption;

WHEREAS, on October 30, 2024, through Ordinance 191936, the City Council adopted the 82nd Avenue Area TIF District Plan;

WHEREAS, the 82nd Avenue Area TIF District Community Governance Charter ("Charter") calls for establishing an 82nd Avenue Area TIF District Community Leadership Committee ("Committee") to advise Prosper Portland and City of Portland ("City") staff, City Council, and the Board on implementation of the 82nd Avenue Area TIF Plan by providing essential guidance, public recommendations, and oversight of implementation;

WHEREAS, Prosper Portland and Portland Housing Bureau staff conducted a public recruitment process for community members interested in serving on the Committee and worked with a selection panel to recommend nominations;

WHEREAS, Committee recommendations on 82nd Avenue Area TIF District Plan implementation are non-binding guidance to decision makers, and it is the intent that recommendations be treated as important and used to shape and guide implementation;

WHEREAS, the Committee will advise City Council and the Prosper Portland Board directly on certain decisions and is a public body pursuant to Oregon Revised Statutes Chapter 192; and

WHEREAS, the Charter specifies the Prosper Portland Board will nominate, or delegate to the Executive Director, seven Committee members of the Committee's thirteen members for initial three-year terms, and the City Administrator's Office will nominate six Committee members for initial two-year terms.

NOW, THEREFORE, BE IT RESOLVED, that the Prosper Portland Board nominates the seven community members listed in Exhibit A to serve on Committee, recommending confirmation by City Council;

BE IT FURTHER RESOLVED, that the Prosper Portland Board hereby delegates any future Committee nominations to the Executive Director; and

BE IT FURTHER RESOLVED, that with the affirmative vote of no fewer than four commissioners for this resolution and of all those present, this resolution will become effective immediately upon its adoption, and otherwise it will take effect thirty days after adoption.
