RESOLUTION NO. 6968

AUTHORIZING THE EXECUTION OF A BARGAIN AND SALE DEED FOR THE DISPOSITION OF REAL PROPERTY LOCATED AT SW NAITO PARKWAY AND HARBOR DRIVE AND NOT WITHIN A CURRENT URBAN RENEWAL AREA TO THE CITY OF PORTLAND

WHEREAS, the Portland Development Commission (“PDC”) is the owner of a 9,000 square foot parcel located at SW Naito Parkway and Harbor Drive (the “Property”), having acquired the Property on October 6, 1966, to facilitate a future park use in implementation of the South Auditorium Urban Renewal Plan (the “Project”);

WHEREAS, the Property was subsequently incorporated into the South Waterfront Project to widen SW Front Avenue in implementation of the Downtown Waterfront Urban Renewal Area;

WHEREAS, the South Waterfront Project, including the SW Front Avenue widening improvements, were constructed by the City of Portland Bureau of Transportation (“PBOT”) with PDC financial assistance;

WHEREAS, the Property is currently used as a traffic island and sewer shaft entrance for the Project and is managed and maintained by and at the sole expense of the City of Portland but is still owned by PDC; and

WHEREAS, PDC and PBOT desire to consolidate ownership of the Property with other property comprising the South Waterfront Project and owned by PBOT.


NOW, THEREFORE, BE IT RESOLVED, that the Chair and Secretary of the Board of Commissioners are authorized to execute a Bargain and Sale Deed substantially in the form attached hereto as Exhibit A (the “Deed”) to convey the Property to the City of Portland;

BE IT FURTHER RESOLVED, that the Deed may be modified to convey the Property to a different City Bureau if requested by the City of Portland;

BE IT FURTHER RESOLVED, that the Chair and Secretary of the Board of Commissioners are authorized to make other modifications to the Deed so long as the modifications, in their opinion and in the opinion of the General Counsel, do not materially increase PDC’s obligations or risks; and

BE IT FURTHER RESOLVED, that this resolution shall become effective immediately upon its adoption.

BARGAIN AND SALE DEED

KNOW ALL PERSONS BY THESE PRESENTS, that the **CITY OF PORTLAND**, a municipal corporation of the State of Oregon, acting by and through the **PORTLAND DEVELOPMENT COMMISSION**, as the duly designated Urban Renewal Agency of the City of Portland (which, together with any successor public agency designated by or pursuant to law, is herein called "PDC"), does hereby grant, bargain, sell and convey to **CITY OF PORTLAND**, a municipal corporation of the State of Oregon, acting by and through the **PORTLAND BUREAU OF TRANSPORTATION** ("PBOT"), and unto its successors and assigns, all right, title and fee interest in and to the following described real property, with the tenements, hereditaments and appurtenances (herein called the "Property"), situated in the County of Multnomah and State of Oregon:

Lots 5-7, Block 111, CITY OF PORTLAND, in the City of Portland, County of Multnomah and State of Oregon. EXCEPT those portions taken for street and highway purposes.

Tax Account No. R246189

Consideration for this conveyance is \$0. The true consideration for this conveyance consists entirely of other value.

The conveyance is subject to the following:

This Deed is made by PDC pursuant to powers exercised by it under Oregon Revised Statutes Chapter 457, and Chapter XV of the Charter of the City of Portland, and with use restrictions consistent with and for the purpose of carrying out an urban renewal plan for the Downtown Waterfront Urban Renewal Plan as has or may be amended.

TO HAVE AND TO HOLD the same unto the said PBOT and unto its successors and assigns forever.

BEFORE SIGNING OR ACCEPTING THIS INSTRUMENT, THE PERSON TRANSFERRING FEE TITLE SHOULD INQUIRE ABOUT THE PERSON'S RIGHTS, IF ANY, UNDER ORS 195.300, 195.301 AND 195.305 TO 195.336 AND SECTIONS 5 TO 11, CHAPTER 424, OREGON LAWS 2007, AND SECTIONS 2 TO 9 AND 17, CHAPTER 855, OREGON LAWS 2009, AND SECTIONS 2 TO 7, CHAPTER 8, OREGON LAWS 2010. THIS INSTRUMENT DOES NOT ALLOW USE OF THE PROPERTY DESCRIBED IN THIS INSTRUMENT IN VIOLATION OF APPLICABLE LAND USE LAWS AND REGULATIONS. BEFORE SIGNING OR ACCEPTING THIS INSTRUMENT, THE PERSON ACQUIRING FEE TITLE TO THE PROPERTY SHOULD CHECK WITH THE APPROPRIATE CITY OR COUNTY PLANNING DEPARTMENT TO VERIFY THAT THE UNIT OF LAND BEING TRANSFERRED IS A LAWFULLY ESTABLISHED LOT OR PARCEL, AS DEFINED IN ORS 92.010 OR 215.010, TO VERIFY THE APPROVED USES OF THE LOT OR PARCEL, TO DETERMINE ANY LIMITS ON LAWSUITS AGAINST FARMING
