Briefing on North/Northeast Economic Development Initiative

### **EXECUTIVE SUMMARY**

## **SUMMARY**

The Portland Development Commission (PDC) Board of Commissioners (Board) directed the Executive Director in December 2008 to initiate the North/Northeast Economic Development Initiative (Initiative) to study current and future areas for possible inclusion in the Interstate Corridor (ICURA) and Oregon Convention Center (OCCURA) Urban Renewal Areas. The next phase of the Initiative is about to begin. The Initiative will be led by a citizen committee which will ultimately recommend to the Board required amendments, if any, to ICURA and OCCURA. The purpose of the Initiative is to evaluate the existing urban renewal areas to determine if there are amendments required to achieve PDC Board or Council goals by either adding areas and/or increasing the Maximum Indebtedness.

### **BACKGROUND**

The PDC Board directed the Executive Director in December 2008 to initiate a study of current and future areas for possible inclusion in the Interstate Corridor (ICURA) and Oregon Convention Center (OCCURA) Urban Renewal Areas (URAs). The OCCURA last date to issue debt is 2013 and it is an Option 3 district.

On May 23, 2007, the Board approved Resolution 6474 initiating a study of all eleven urban renewal areas over time. This effort is known as the Future of Urban Renewal. To date, studies have been performed on Central Eastside, Downtown Waterfront, South Park Blocks, River District, and Lents Town Center URAs. Amendments have been passed for all five districts.

Current projects include the North/Northeast Study, as described above, as well as the Central City URA Study which is being led by the Mayor's Central City Evaluation Committee. Their objective is to recommend to City Council and the PDC Board the priorities, key goals, boundaries and maximum indebtedness of a new urban renewal area in the west central city area.
