### **RESOLUTION NO. 7393**

AUTHORIZING AN AMENDMENT TO AN INTERGOVERNMENTAL AGREEMENT WITH THE CITY OF PORTLAND BUREAU OF TRANSPORTATION FOR THE FOSTER STREETSCAPE PROJECT IN THE LENTS TOWN CENTER TAX INCREMENT FINANCE DISTRICT

**WHEREAS,** Prosper Portland is undertaking the Lents Town Center Urban Renewal Plan, adopted August 27, 1998, and subsequently amended ("Plan");

**WHEREAS,** the Plan supports developing a transportation system which enhances neighborhood livability and mobility, including pedestrian-friendly improvements;

WHEREAS, the Prosper Portland Board of Commissioners ("Board") approved an Intergovernmental Agreement ("Original IGA") between Prosper Portland and the City of Portland Bureau of Transportation ("PBOT") in the amount of \$1,453,956 to support streetscape improvements to Foster Road in the Lents Town Center Tax Increment Finance District ("Project") pursuant to Resolution No. 7225, adopted December 14, 2016;

**WHEREAS,** PBOT encountered cost increases in connection with the Project due to unusually high bid costs and existing roadway conditions;

WHEREAS, Prosper Portland staff recommends the execution of an amendment to the Original IGA ("Amendment") to, among other things, provide an additional \$650,000 to assist PBOT with addressing such cost impacts, thereby increasing Prosper Portland's total funding amount from \$1,453,956 to \$2,103,956; and

WHEREAS, in exchange for Prosper Portland's investment in the Project, PBOT recommended to City Council the addition of \$5,000,000 in eligible project costs to the Transportation System Development Charge Capital Project List entitled Post Office Blocks Transportation Improvements, Phase 1, whose improvements include but are not limited to extending Park and Johnson streets through the Broadway Corridor redevelopment site and adding traffic signals at NW 9th Avenue and Everett Street and NW 9th Avenue and Glisan Street intersections located in the River District TIF District.

**NOW, THEREFORE, BE IT RESOLVED,** that the Prosper Portland Board authorizes the Executive Director to enter into the Amendment attached hereto as Exhibit A;

**BE IT FURTHER RESOLVED,** that the Executive Director may approve changes to the IGA if such modifications, in the opinion of Prosper Portland's Executive Director in consultation with Prosper Portland's General Counsel, do not materially increase Prosper Portland's obligations or risks; and

**BE IT FURTHER RESOLVED,** that this resolution shall be effective immediately upon its adoption.

# FIRST AMENDEMENT to INTERGOVERNMENTAL AGREEMENT Between Prosper Portland And Portland Bureau of Transportation For the Foster Streetscape Project Final Design and Construction

This First Amendment to Intergovernmental Agreement (this "Amendment") is made and entered into by and between the City of Portland, Bureau of Transportation ("PBOT") and Prosper Portland, assumed business name of the Portland Development Commission, the urban renewal and economic development agency of the City of Portland ("Prosper Portland") as of the date signed by each of the parties.

## Recitals

- A. Prosper Portland and PBOT to a certain Intergovernmental Agreement dated August 31, 2017 (the "Agreement"), pursuant to which Prosper Portland agreed to provide \$1,453,956 in funding towards PBOT's planned streetscape improvements on Foster Road (as described in the Agreement, the "Project").
- B. PBOT encountered cost increases in connection with the Project due to unusually high bid costs and existing roadway conditions. Prosper Portland wishes to amend the Agreement to, among other things, (i) provide an additional \$650,000 to assist PBOT with addressing such cost impacts, thereby increasing the total funding amount from \$1,453,956 to \$2,103,956, and (ii) extend the outside billing date to September 1, 2020 and termination date to September 30, 2020.

# Agreement

- 1. <u>Prosper Portland</u>. The parties agree that all references to Portland Development Commission or PDC in the Agreement shall be deemed references to Prosper Portland, which was adopted as the assumed business name of the Portland Development Commission in 2017.
- 2. Funding.
  - a. Section I(A) of the Agreement is hereby modified as follows:

- The first sentence of the second paragraph of Section I(A) of the Agreement is modified by replacing the amount "\$2,000,736" with the amount "\$2,650,736";
- The first sentence of the fourth paragraph of Section I(A) is modified by replacing the amount "1,453,956" with the amount "\$2,103,956"
- b. Section 3(A) of the Agreement is hereby modified as follows:
  - Section 3(A) is modified by replacing the amount "\$1,453,956" with the amount "\$2,103,956"
- c. The sources budget in Section 3(C) of the Agreement is hereby modified by addition of the following row:

# 3. Timing.

- a. The reference to "January 1, 2017" in Section 4(A), subsection 2, is hereby replaced with a reference to "September 1, 2020".
- b. The reference to "December 31, 2019" in Section 5(A) is hereby replaced with a reference to "September 30, 2020".
- 4. <u>General</u>. All terms and conditions not expressly amended by this Amendment remain unchanged.
