6. Action Item: Resolution 7447 - Authorizing the Executive Director to Execute a Letter of Agreement Between Prosper Portland and American Federation of State, County, and Municipal Employees, Council 75, Local 3769 to Extend the Parties’ Collective Bargaining Agreement by One Year

With this action the Prosper Portland Board authorized the Executive Director to execute a Letter of Agreement between Prosper Portland and American Federation of State, County, and Municipal Employees, Council 75, Local 3769 (AFSCME) which was negotiated by authorized representatives of Prosper Portland and AFSCME, amending the parties’ Collective Bargaining Agreement (CBA).

Ms. Whitney shared the current CBA was set to expire in June 2022, and due to the many impacts of COVID-19 the union and management agreed to extend and amend the contract for one year. Mr. Gonzalez shared that he appreciated the work put into this effort.

Chair Cruz called for a motion to approve Resolution No. 7447; Commissioner Stoudamire Wesley moved and Commissioner Platt seconded the motion.

7. Information Item: Update on the Old Town Action Plan

Mr. Kerosky reviewed the history of Old Town noting it was an entry point for many diverse immigrant populations. Mr. Kerosky continued by reviewing past investments in Old Town prior to the initiation of the Old Town Five-Year Action Plan (Action Plan) in 2014 which was subsequently extended in 2019 to the year 2024.

Mr. Kerosky detailed the Action Plan priorities, budget, neighborhood investments as well as investments in cultural institutions.

Mr. Dinkelspiel described Prosper Portland's response to COVID-19 in Old Town noting several events created for business activation in the neighborhood. Mr. Dinkelspiel noted some businesses were recruited during this time as well as those retained.

Chair Cruz invited guests forward to testify.

Nataliya Garcia, small business owner, and member of the Old Town Community Association. Ms. Garcia listed many of the events she and OTCA have organized to help activate Old Town. Ms. Garcia provided a flyer for an upcoming event. (See Attachment 1.)

Mr. Barnes provided an update on the fiscal year 2022-23 Proposed Budget and detailed next steps as follows: after Prosper Portland Board input and direction, staff will finalize the Proposed Budget in April and present it to the Portland City Council acting as the Prosper Portland Budget Committee, in May 2022. City Council is expected to approve the Proposed Budget on May 18, 2022, after which, staff will seek the Prosper Portland Board's adoption of the City Council-approved Proposed Budget at its June 7, 2022, meeting.
