WHEREAS, Francesca Gambetti has engaged as a leader in Portland Means Progress, participating in racial equity actions and championing the culture change in the private sector;

WHEREAS, Francesca Gambetti has been a strong proponent of the agency's grant and loan programs to stabilize and enable the growth of local businesses and community based organizations within the city;

WHEREAS, Francesca Gambetti has provided guidance and strategic direction on the agency's mixed-use, mixed-income projects, including in Lents and Gateway, to help stabilize residents and small businesses and to counter gentrification by making investments in both market rate and affordable housing in collaboration with the Portland Housing Bureau;

WHEREAS, Francesca Gambetti has helped lead the agency through historic times, ensuring continuity and prioritization of agency operations on addressing the economic impacts of the COVID-19 pandemic on Portland's businesses and employees through investments and programs like the Portland Small Business Relief Fund, providing direct loan and lease deferrals, and offering various tools and resources for small businesses and nonprofits navigating a phased reopening;

WHEREAS, Francesca Gambetti volunteered significant time away from her family and her practice to ensure Prosper Portland's mission and vision for the city would be achieved;

WHEREAS, Francesca Gambetti has leveraged her professional expertise and her personal commitment to serve the community in her able representation of the City of Portland as commissioner of Prosper Portland; and

WHEREAS, Francesca Gambetti has diligently and forthrightly carried out her civic duties on behalf of Prosper Portland and in the best interests of the city.
