7. Information Item: Update on the Inclusive Economic Development Strategy

Prosper Portland staff and invited guests presenting this item: Shea Flaherty-Betin, Economic Development Director Camille Trummer, Camille E. Trummer Consulting, LLC Cecilia Estolano, Estolano Advisors Ashley Bakelmun, RW Ventures, LLC Robert Weissbourd, RW Ventures, LLC

Mr. Flaherty-Betin introduced the item.

Ms. Trummer who is leading the Community Engagement, noted her organization is prioritizing and engaging communities who have historically been left out. Ms. Trummer shared key findings and reviewed the interviews completed by RW Ventures and Estolano Advisors.

Ms. Estolano, who is leading the Climate and Equity Lens scope, shared the team's main deliverables noting, 1.) threshold criteria, 2.) process considerations, and 3.) implementation expectations.

Ms. Bakelmun addressed in detail, approaches to the project including but not limited to, 1.) innovation, governance, and special efficiency, 2.) pathways to inclusive growth, 3.) takeaways from market analysis, 4.) research, development, and innovation. Ms. Bakelmun continued by identifying the problem and vision statement, reviewed objectives and proposed strategic initiatives.

Ms. Harpole reviewed the project and roles of Prosper Portland, the City of Portland, and development partners.
