With this action, the Prosper Portland Board updated the delegation of general administrative authority to the Prosper Portland Executive Director to eliminate the need for redundant approvals and provide clarity to staff on when and in which circumstances the Executive Director is authorized to enter into agreements without Prosper Portland Board approval.

7. Action Item: Resolution 7577 - Appointing Shea Flaherty Betin to Serve as Prosper Portland Interim Executive Director

Prosper Portland staff presenting this item: Hope Whitney, General Counsel

With the action, the Prosper Portland Board appointed Shea Flaherty Betin to serve as the interim Executive Director of Prosper Portland. Additionally, the Prosper Portland Board recommended that the Interim Executive Director appoint Lisa Abuaf as Interim Deputy Director.

Chair Cruz called for a motion to approve Resolution No. 7577, Commissioner Slick moved, and Commissioner Stoudamire Wesley seconded the motion.

8. Action Item: Resolution 7578 and 7579 - Approving Terms of a Purchase and Sale Agreement with Beam Construction & Management LLC and Colas Development Group LLC for the 0.80-Acre Prosper Portland-Owned Parcel Between SE Salmon, SE Water, and SE Main Streets and Approving Terms of an Exclusivity Term Sheet with Buyer for 1.39 Acres of Prosper Portland-Owned Property Between SE Taylor, SE Water, and SE Madison Streets within the Central Eastside Tax Increment Financing District

Prosper Portland staff presenting this item: Lisa Abuaf, Director Investment & Development Amy Nagy, Development Manager

With this action, the Prosper Portland Board authorized the Executive Director to i) approve the disposition of the 0.8-acre parcel known as Workshop Block B to Beam Construction & Management LLC and Colas Development Group LLC (Buyer) at the appraised market rate of \$2,410,000, and ii) execute a Term Sheet with the Buyer for the potential development of two adjacent parcels known as Workshop Blocks A and C.

These actions set a fundamental framework and structure in the form of a Purchase and Sale Agreement related to Workshop Block B (Block B) and a Term Sheet related to the development of Workshop Blocks A & C (Blocks A & C). The Term Sheet for Blocks A & C will guide the basis for negotiating purchase and sale agreements or long-term lease agreements related to those individual blocks.

Ms. Abuaf discussed the Purchase and Sale Agreement of Block B and the term sheet for the potential development of Blocks A & C, provided details regarding the engagement process, and shared an overview of the state of the central city and impact of pandemic on office and retail vacancy rates.

Ms. Nagy shared the results of the third-party economic impact study and findings from the engagement process.



Ms. Nagy provided an overview of the proposed entertainment venue and potential benefits, noted the Block B timeline and next steps of sale, venue development and operations, and reviewed the term sheet for both Blocks A & C as well as the development agreement.

Chair Cruz called for invited testimony

Jonathan Malsin, Beam Development, spoke to the benefits of bringing the project to Portland.

Andrew Colas, Colas Development and Construction, shared why they pivoted to development of a music venue. Mr. Colas reminded the Board there is no public subsidy and they have met all requirements that go with public private partnership. Mr. Colas noted jobs will go to people of diverse backgrounds and be a catalyst for good paying jobs.

Nate McCoy, President, CEO, National Association of Minority Contractors, noted this project will provide 400 well-paying union jobs for people of color and women and will grow and scale small business.

Bridgid Blackburn, Cargo (via Zoom), works with the Central Eastside Industrial Council noted the blocks have been a blight for years.

Chair Cruz called forth public testimony.

Jesse Valencia, musician, actor, and member of Portland Music requested a delay in selling Block B to Beam for the development of Live Nation.

Kate O'Brien, Board President, Music Portland, speaking on behalf of themself, husband, and children, spoke against Live Nation.

Alex Blosser, Associate at Strategy 360, testifying on their own behalf, spoke against Live Nation's business model.

Rene Muzquiz, Director Operations, Music Portland, and musician requested the board collect more public input.

Shelby Kray, Blue Heron Video, Portland Public Schools art teacher and Documentarian of Portland music venues, requested to delay the vote and collect more public input.

Marshal Runkel, Strategies 360, representing Monkey's Present, spoke in opposition to the land sale and to lawsuits against Live Nation by the Department of Justice. Spoke of a similar project that could fulfill the same venue size need.

Cheri Jamison, ED, Alberta Abbey, requested to delay the decision and collect more public input. Also submitted written testimony (See Attachment 1).

Timothy Wilson, Starlet Farm and Board member, Music Portland, shared concerns around the public process stating it was not completed.

Katelyn Convery, small business owner, spoke in opposition to Live Nation.

Jamie Dunphy, Music Portland, spoke in opposition of the sale of Block B.

Derek Trost, spoke in opposition to the land sale for the development of a venue by Live Nation.

Meara McLaughlin, Co-founder Music Portland, spoke in opposition to Live Nation.

Philip Graham, spoke in opposition to the land sale for the development of a venue by Live Nation.



Riley Kennedy-Keys, musician, recording engineer, spoke in opposition to the land sale for the development of a venue by Live Nation.

Jay Clark, Portland Metro Chamber, Director Government Affairs, spoke in favor of the sale of Block B to Beam and the development of a venue by Live Nation for the benefit of the local economy.

Nathan Carson, Nanotear Booking Agency, spoke in opposition to the land sale for the development of a venue by Live Nation.

Liz Gabriel, Near Hear, spoke in opposition to Live Nation.

Commissioner Hagins requested the terms of the lease be shared with the Board.

Commissioner Slick encouraged Music Portland to partner with Beam and Colas to hold Live Nation to the terms of the lease.

Chair Cruz declared his abstention and Commissioner Alvarez declared his potential conflict.

Commissioner Hagins made a motion to delay the Board's vote after it has the opportunity to review the lease between the development team and its tenant. Chair Cruz called for a second, there was none, so the motion failed.

Chair Cruz called for a motion to approve Resolution No. 7578, Commissioner Stoudamire Wesley moved, and Commissioner Slick seconded the motion.

Action Item: Authorizing a Forgivable Loan in an Amount Not to Exceed \$10,000,000 to Williams & Russell Community Development Corporation and Black Business Hub, LLC for Environmental Remediation, Predevelopment, and Construction on Certain Property Bounded Approximately by N Williams Avenue, NE Russell Street, N Vancouver Avenue, and NE Knott Street in the Interstate Corridor Tax Increment Financing District

Prosper Portland staff presenting this item: Amy Nagy, Development Manager Kay Little, Asset & Investment Manager Charles Funches, Project Manager I



With this action, the Prosper Portland Board authorized the Executive Director to make a \$10,000,000 forgivable loan to the Williams & Russell Community Development Corporation and Black Business Hub, LLC (BBH) for environmental remediation of an approximately the 2.1-acre site in the Interstate Corridor Tax Increment Finance District and for predevelopment/construction by BBH of a business hub project on a portion of the site.

Chair Cruz called forth guest testimony.

Azalea Renfield, ED of Williams & Russell CDC, emphasized the action will impact the Albina community in a transformational way creating wealth opportunities.

J.T. Flowers, Albina Vision Trust, Director Government Affairs, reviewed the history of the site including the seizure of property from Black homeowners and Black businesses and spoke in favor of adopting the resolution.

Ms. Nagy reviewed the history of the project and site and walked through key milestones from 2015 to present day. Ms. Nagy listed the partnerships involved with the project.

Ms Nagy detailed engagement led by the Project Working Group to learn community priorities, values, and to inform the choice of a development team.

Mr. Funches described the vision for the three projects; business hub, affordable apartments, and affordable homeownership. Mr. Funches reviewed the environmental remediation scope and cost assumptions.

Mr. Little reviewed the loan and highlighted key aspects of the term sheet. Mr. Little stated initial funds were released for remediation of the site and any remaining funds will be allocated toward the business hub

Commissioner Stoudamire Wesley departed the meeting at approximately 6:40 and was not present for the vote.

Chair Cruz called forth guest testimony

Anyeley Hallova, Founder, Adre, noted the project will be a national model for restoring economic justice and affordable housing which will positively impact future generations.

Bryson Davis, President and Board Chair, Williams & Russell, co-chair, former Project working Group, reviewed the history of the land and harm inflicted on the Portland Black community. Mr. Davis stated working with Prosper Portland, the City of Portland, and the Portland Housing Bureau has allowed the community to design and build the project and is creating both wealth and faith restoration.

John Washington, Executive Director, Soul District Business Association, stated this project should be a model for the entire county as it was modeled to build hope and upward mobility.

Justice Rajee, Secretary, Williams Russell CDC, shared the process of learning to trust Prosper Portland, the City of Portland, and Portland Housing Bureau, noting trust will be rebuilt if the item is passed.

Karis Stoudamire-Phillips acknowledge the three entities that came together and is counting on Prosper Portland to follow through.

Chair Cruz called for public testimony.

Chris Smith, No More Freeways, spoke in support of the resolution.



Heidi Hart, Portland Neighbors Welcome, spoke in support of the resolution.

Chair Cruz called for a motion to approve Resolution No. 7580, Commissioner Hagins moved, and Commissioner Alvarez seconded the motion.

Tory Campbell compared the effectiveness of ED Branam's leadership, modeling how to be a champion, demanding drive, focus, and strategy.

Chair Cruz called for a motion to approve Resolution No. 7580, Commissioner Hagins moved, and Commissioner Slick seconded the motion.

Mary-Ann Schwab City Council Testimony Script

Good evening, Mayor Wheeler and Portland's Commissioners,

My name is Mary-Ann Schwab. I am a retired school secretary and longtime resident of the Sunnyside neighborhood. I am here tonight to speak about something of great importance to me, and has been for a long time: the long-awaited community center for SE Portland next to the old Washington High School. In fact, the last time I was in your office, Mayor Wheeler, was to speak on this same issue, and nothing much has happened since.

This community center has been long-awaited and badly needed. There is currently no full-service community center easily accessible to most SE Portland residents. In 1991, the Buckman Neighborhood Plan identified a need for such a full-service community, a proposal which received public support and was later included in the Portland Parks & Recreation's Parks 2020 Vision. In 2003, Parks & Rec. decided based on citizen feedback to use some of the property near Washington High School. Another Project Advisory Committee, which I served on, unanimously decided in 2010 to recommend building the center on the field next to the school. And the city even had a land use proposal for the two-story, 60,000 square foot center, complete with outdoor open spaces, parking, an indoor pool, as well as exercise, activity, meeting, and class rooms approved in 2012, with a total projected cost of \$48 million dollars.

However, the field next to the old Washington High School lies as vacant as it did all those years ago. Put simply, there has not been any progress since. Currently, the area set aside for the park lies vacant, and is listed on Google Maps a "Washington High School Dog Park" even though the area is not, in fact, a dog park. Why? The project has been stalled ever since it was decided in 2010 not to seek a bond measure that would be necessary to fund the project, even though that potential bond measure received strong support from the citizens and city government officials on the Project Advisory Committee I served on. As we all know, Portland Park & Rec. has historically struggled with insufficient funding to operate, maintain, and grow its vital parks system, a problem that will only become worse once the Parks Local Option Levy expires without being renewed or the department receives funding to replace it.

This project has been a dream of SE Portland for many years. Southeast Uplift, a non-profit which serves the area's community and neighborhoods, even described it in 2015 as a promise now unmet for over three decades. I am asking you in hopes that the city can finally include funding for this promised community center in the next twenty year funding plan, and that the city take the kind of action necessary to properly fund the parks system, so that children in Southeast Portland don't have to wait another twenty years.

As an aspiring musician with a day job, I could not speak to you in person today, in part because meeting details were posted less than 24 hours in advance, so I am submitting written testimony instead.

You are hopefully aware of the negative impacts of building a Live Nation/Ticketmaster venue on the central eastside. Let's take a quick look:

You should know that Live Nation is being sued by the Federal Gov't and dozens of states for anti-competitive behavior; how they follow a playbook in city after city to disrupt and seriously injure vibrant local music scenes; how one great appeal of Portland to both residents and visitors is our independence, our small businesses, a music and arts scene that doesn't just serve up the same old thing you can find in any other U.S. city. People don't need to come all the way to Portland to hear Nickelback and eat at McDonald's (though it's fine if they do), they can do that in any other big city.

All of this is known, it has been known for years. Are you paying attention?

Dear Prosper Portland Commissioners -

My name is Laura Streib. I am a musician, an artist, an arts advocate and consultant and the founder and Executive Director of the arts educational nonprofit Vibe of Portland.

I am writing to express my strong opposition to Report 24-26, Resolution 7578, and Resolution 7579 regarding the proposed sale of public land known as the "ODOT Blocks," specifically Block B, for the development of a music venue by BEAM and Colas for Live Nation.

This parcel of land was designated for a Request for Proposals (RFP) in 2017 and 2018, intended to support the revitalization of the Central East Side, particularly in the area known as the workshop blocks. The original RFP awarded a 100-year lease to foster industrial, creative, and office space, along with parking to support these uses. The current proposal to sell this land undermines the vision established in that RFP and deviates from the original intent.

Furthermore, I have serious concerns about Live Nation's track record. The company has consistently violated lease agreements and consent decrees and employed unfair and illegal business practices in cities across the country. Granting them control over this public land poses a significant risk to our community and contradicts our goals for responsible and ethical development. Live Nation is also currently being sued by the US Department of Justice and 40 US States (including Oregon) for violating antitrust laws.

Live Nation has already begun to violate the terms of their agreements with the City of Portland and their lease agreement with the City for the live performances at Providence Park that have just started this summer.

The lack of transparency and the urgency surrounding this sale are also troubling. Rushing



this decision without adequate time for public comment and oversight is not in the best interest of our residents. The potential impacts of this development deserve thorough examination and dialogue with those who will be directly affected. The pushing through of this sale without public comment also goes directly against the City of Portland's own city policy BCP-ADM-4.02 - Public Involvement Principles established in 2008 to increase the legitimacy and accountability of government actions.

I urge you to vote against the sale of this public land. We must honor the commitments made in the original RFP and prioritize the needs of our community over the interests of a private entity with a questionable reputation.

Dear Prosper Portland Board of Commissioners,

I write to you with deep concern for our local music ecosystem and everyone involved in it. I respectfully urge you to delay the decision on the proposed sale of public land for a Live Nation-owned and operated music venue.

My name is Cheri Jamison, and I have spent the past two years as an independent arts and nonprofit consultant in the Portland metro area. In early 2023, MusicPortland hired me to help lead the Oregon Music Census, a project initiated by the Oregon State Legislature. We partnered with Business Oregon and the Northwest Economic Research Center at Portland State University to conduct this landmark economic impact study. The study revealed that commercial music contributes \$3.8 billion to Oregon's economy, with over 75% of that impact concentrated in Portland. Commercial music and live performance have now been recognized as emerging industries in Oregon: Oregon Emerging Industries Report.

Following the census, I joined MusicPortland's Music Policy Council as a volunteer. Over the past two years, I have closely observed the developments regarding the proposed Live Nation venue in the Central Eastside. Recently, I was appointed Executive Director of the Alberta Abbey, a nonprofit, independent performing arts venue in NE Portland. From my experience both as a consultant and in my new leadership role, I know firsthand that artists, nonprofits, and independent venue owners—both for-profit and nonprofit—are all struggling to survive. Despite the sector still recovering from the disruption of the COVID-19 pandemic, Portland's independent music scene remains a significant economic force.

We need support, not a Live Nation venue.

Our opposition is not directed at the developers but specifically at Live Nation/Ticketmaster, a company with a well-documented history of unfair business practices. The U.S. Department of Justice and 40 states, including Oregon, are currently suing Live Nation for antitrust violations. Live Nation's monopolistic behavior is a threat to independent music culture.

As you consider this decision—whether the extended lease or sale of the land to the developers—you must take into account Live Nation's involvement. The Portland music community has been raising the alarm, and we urgently ask that you listen.

I respectfully request that you delay the decision on this public land sale. There has not been enough public notice or input regarding a decision that will profoundly impact an entire industry.



Hello,

This testimony is in response to action item 8 on your agenda for today's meeting, I've included it in the body as well as an attached PDF. I am a native Portlander, real estate professional, owner of multiple small-businesses, including my music business:

The question today is does the construction and operation of a Live Nation venue in the City of Portland demonstrate a clear public benefit?

The answer is simply no. Their responsibility is to shareholders states and oceans away. Our public benefit is not their objective. They are here to extract resources, and in doing so, capital will leave our economy and the pockets of our independent artists, the drivers of our culture.

Culture and art drive economies. Artists are important. Think of any place you've dreamed of visiting: Barcelona for example, famed, utterly-unique Antoni Gaudi's Sagrada Familia is visited 3 million times a year. Why travel to Salzburg? To experience the birthplace of Mozart. Artists, their ideas, the experience they provide, those are our crown jewels. It is this artistic wealth, which we already possess, that Live Nation plans to extract and sell back to us. It is artists and their fans, the interplay, the sacred experience of live music, that Live Nation commodifies and plans to control in every way.

It does not need to be this way. We can be the visionaries our city needs, we can follow in the footsteps of past Portland visionaries that bestowed to us our parks, our walkable, small-business-friendly neighborhoods, our protected natural areas, our unique way of life and culture that people from all over the country and world now come to experience and contribute to. Thanks to them, this city is the best of the best, and attracts the best of the best including musicians. We must

carry the torch and create a city rich in culture that our children's children will thank us for.

My great-grandmother who moved here from South Dakota in 1945 would not have believed that the major highway Harbor Dr, winding along our westside waterfront, would become Waterfront Park in 1978. It was created through citizen activism and partnership with the citizens of The City Club of Portland, the Downtown Plan Citizen Advisory Committee and then The Waterfront Park Master Plan which included surveys, and citizen meetings with an average attendance of 500 people. This was a huge community undertaking and today we have one of the most livable city centers in the nation thanks to the citizens who could envision a world class park where a 6-lane highway used to be. It is now named after Gov Tom McCall, who championed its creation.

We could do the exact same thing with a locally-owned, 3,500 seat venue. We could fund it ourselves, with private patrons, locally-owned businesses and tax dollars. Someone could put their name on it, build a legacy that lasts 100s of years. We could involve our art community and architects to build a stunning, one-of-a kind, state-of-the-art venue, one of the best in the country and world where we showcase our local talent and help grow their following and their creative output until their careers become widely recognized and they become a symbol of our culture and drive an industry for decades to come. We could make it a sacred place, not a corporatized space. Like Pioneer Square is our living room, Waterfront Park is our front yard, our venue could be our temple. The place we showcase and venerate our artists.

In the year leading up to my album release in June 2023, I spent about \$30,000 in the Portland music industry. About \$5,000 of that was a grant from Music Portland. The rest was my hard-earned income from work outside music. This money was all spent locally in studios, on players, graphic designers, videographers, photographers, stylists, make-up artists, gear, sound engineers, mastering engineers, vintage clothing. I am not the only artist investing in our music industry. We are

hard-working, talented, passionate and over-looked. We are already spending non-music income in the local music industry because our products, the music itself, is no longer a source of significant income for us, the majority of our music-income is from performances. What will happen to us when we can no longer find a place to play in our own city? If we don't have the opportunity to develop our sounds with our fans. When Live Nation shuts us out of our home market while they parade their own artists through our town?

If you aren't catching a show in this city once a week, I could understand that you are not aware of the extraordinary quality and breadth of the Portland music industry. I've been playing stages here since 2008, so let me report back to you, we are on the verge of something big. Now is the time to invest in the Portland music industry and bring more fans to our shows so we may have a chance to build our careers and continue spending our money here and one or many of us may have a chance to make the name for ourselves that will put a stamp on our city.

Don't miss this chance to involve your citizens and artists in something that could make history and be your legacy. Inviting Live nation in to lay waste to our cultural equity that generations of Portlanders have worked hard to create is not the way forward. We are better than this. We can be the exception, let us be the "weird" one in the country. The only major city to not have a Live Nation venue. Let us continue building our unique and valuable Portland culture. Let the public benefit from our investment in the local music industry.

My name is Meara McLaughlin, and I co-founded MusicPortland in 2018, where I currently serve as Executive Director. MusicPortland is the first nonprofit trade association dedicated to representing the interests of Oregon's commercial music sector. For nearly seven years, alongside a committed team of volunteers, I have worked to unite, assess, and advocate for this sector as a vital economic and cultural force within our city and state.

Despite media reports that often minimize our opposition to Live Nation as simply 'a group of local musicians,' MusicPortland represents over 700 Portland-area music businesses. From CD Baby to instrument manufacturers, gear makers, and audio production companies, we speak for the entire ecosystem. We also represent over 9,000 unique recording acts and more music-hosting spaces than Nashville or Austin.

The most vulnerable to Live Nation's market dominance are the 50 dedicated music venues and over 200 mixed-use venues that host live music regularly. It is striking that none of these respected local venues have publicly supported our campaign. Their silence is a powerful indicator of the control that Live Nation holds over this creative economy. In other cities, Live Nation's practices have included closing independent venues that compete or 'offend'—as noted in the DOJ lawsuit. Here in Portland, I have spoken to many venue owners who privately support our efforts, but they fear retaliation if they speak out. Many of these venues are already operating on razor-thin margins.

This culture of fear does not foster a healthy business environment. It should not be allowed to take root, nor should it be encouraged with unearned advantages—especially by those entrusted with fostering local entrepreneurship and economic growth.

Please do not commit to sale of this property on this unprecedented fast track. If this is a good deal for Portland, then it will hold up in the light of scrutiny and time for public opinion.

Dear Prosper Portland Board of Commissioners,

It is with utmost urgency and respect that I ask the board, on behalf of myself and my local music economy, to delay the proposed Live Nation sale consideration.

I have worked in the music industry for the Smithsonian, the National Council of the Traditional Arts, the National Endowment for the Arts and in venues all over the US for independent musicians as well as those signed by labels and management teams. I have seen and heard time and time again how Live Nation employs predatory, one-size-fits-all practices towards up and coming artists that utterly kill local music economies in their cradle.

We were just made aware of the the sale proposal last week, the details were posted today, and there is already a meeting scheduled less than 24 hours later, in the middle of the day when many people will be at work or frankly getting their gear together and loaded up to go to a sound check somewhere around town.

What's the rush? Why the cloak and dagger? What is it that cannot withstand the light of day and full public knowledge or commentary? If Live Nation is putting pressure on the board to move this quickly, all the more reason to slow down as the commissioners are now glimpsing how the company can wield its influence and power on city organizations. Imagine what they can do to small artists with no resources beyond their community and what they can make in an evening. Some of their contract clauses forbid artists from playing within 150 miles, and/or a five state radius in exchange for having them play ONE festival. Not even in a headline slot. That's predatory for Rhode Island, let alone the west coast. If our local artists had to abide by that in order to be noticed at all by their booking, it's forced pay to play because they would need to abandon building audiences between Portland and effectively Canada. That is impossible for most touring acts, including large ones because one festival is not going to build sustainable audiences or income. Nor will the profit from one festival offset the loss materially or otherwise.

Please, please slow down on this proposal. This company is under a DOJ anti-trust investigation that at least ten other states and our nation's capital have joined. Why would we want to let a national chain with known predatory practices get into bed with the city without doing a full background check first? Portland doesn't like big box anything to begin with and frankly it's a terrible dating practice. Also affirmative consent of the governed comes to mind...if they say they can't wait any longer then they aren't actually serious about committing anything to the Portland community and it shows the company to be openly extractive.

Please wait so more nuanced conversations can happen with all of the stakeholders to make sure any deal, if reached, is actually beneficial to the people of Portland, especially those who are actively working every day in the music economy. Heck, my landlord is a venue co-owner, Oregon Music Hall of Fame inductee, and actively gigs every night around towel at small venues while mentoring young musicians. If Live Nation comes in and venues go under, he could lose his business, his house, everything. And the industry tenants who depend on just

this one person being stable would have no place to turn for practice space or frankly even housing that is actually affordable. And that's just the knock on effects from one venue and musician being taken out. Imagine the lost tax revenue if nothing else.

Absolutely do not take Live Nation's assurances of goodwill at face value. I've seen the wreckage of music economies in cities that did. One bad decision now could effect the next twenty to fifty years of artists in a time when the industry, nationally, is slowly waking up to the fact they have failed up and coming bands and there's very few people left they can even put on stage that would even be able to draw 2500 cap. That is due in large part to the profit at any cost, monopolistic practices employed by corporations like Ticketmaster and Live Nation.

Slow it down. Back the truck up, and let's please have a moment to kick the tires before we zoom off straight into a wall. I'd say before we all start hearing American Pie being played in the background, but by the time the city realizes it needs a dirge to it's music industry there won't be any local, affordable musicians left to play it.

Good afternoon Commissioners,

My name is Jamie Dunphy. I'm writing to provide important background on the history of the ODOT Blocks RFP, which Agenda Item 8 is directly related to.

In 2018, I served as Senior Policy Director for Portland City Commissioner Nick Fish. In that capacity, I served on the ODOT Blocks RFP Selection Committee, which approved the proposal from Beam Development and Colas Construction for a three-block development that included industrial maker space, commercial space, office space, and desperately needed parking capacity.

In the spring of 2022, the Willamette Week reported that the scope and scale of this proposal had changed dramatically to now feature a partnership with Live Nation to build a 3,500 person music venue.

Live Nation, the owner of Ticketmaster, is the largest entertainment corporation in the world. They are currently being sued by the US Department of Justice and 40 US States, including Oregon, for violating antitrust laws. They seek to break up the Live Nation/Ticketmaster monopoly. Live Nation has violated consent degrees with the US Department of Justice over their unfair labor practices and illegal consolidation of the music venue, tour management, artist management, ticket sales, merchandising, and concessionaires industry. Additionally, they have already been violating the terms of their agreement with the City of Portland at Providence Park, including using fireworks without appropriate permiting and violating their noise levels, and have refused to meet with City of Portland staff to consider.

This proposal before the Prosper Portland board of directors is to change the terms of this agreement again. Prosper Portland staff are now proposing the disposition of Block B at current market value, while retaining the land under Block A and C for 100 years. This action to sell the public land was only posted on the public agenda this morning. The scope of this proposal is dramatically different than what was approved in 2018. It is unclear why this change is happening now, and does not feel aligned to the goals Prosper Portland first envisioned when the ODOT Blocks RFP was awarded six years ago.

Musician and Small-Business Owner's Testimony Against Live Nation Katelyn Convery 9/18/24

The question today is does the construction and operation of a Live Nation venue in the City of Portland demonstrate a clear public benefit? The answer is simply no. Their responsibility is to shareholders states and oceans away. Our public benefit is not their objective. They are here to extract resources, and in doing so, capital will leave our economy and the pockets of our independent artists, the drivers of our culture.

Culture and art drive economies. Artists are important. Think of any place you've dreamed of visiting: Barcelona for example, famed, utterly-unique Antoni Gaudi's Sagrada Familia is visited 3 million times a year. Why travel to Salzburg? To experience the birthplace of Mozart. Artists, their ideas, the experience they provide, those are our crown jewels. It is this artistic wealth, which we already possess, that Live Nation plans to extract and sell back to us. It is artists and their fans, the interplay, the sacred experience of live music, that Live Nation commodifies and plans to control in every way.

It does not need to be this way. We can be the visionaries our city needs, we can follow in the footsteps of past Portland visionaries that bestowed to us our parks, our walkable, small-business-friendly neighborhoods, our protected natural areas, our unique way of life and culture that people from all over the country and world now come to experience and contribute to. Thanks to them, this city is the best of the best, and attracts the best of the best including musicians. We must carry the torch and create a city rich in culture that our children's children will thank us for.

My great-grandmother who moved here from South Dakota in 1945 would not have believed that the major highway Harbor Dr, winding along our westside waterfront, would become Waterfront Park in 1978. It was created through citizen activism and partnership with the citizens of The City Club of Portland, the Downtown Plan Citizen Advisory Committee and then The Waterfront Park Master Plan which included surveys, and citizen meetings with an average attendance of 500 people. This was a huge community undertaking and today we have one of the most livable city centers in the nation thanks to the citizens who could envision a world class park where a 6-lane highway used to be. It is now named after Gov Tom McCall, who championed its creation.

We could do the exact same thing with a locally-owned, 3,500 seat venue. We could fund it ourselves, with private patrons, locally-owned businesses and tax dollars. Someone could put their name on it, build a legacy that lasts 100s of years. We could involve our art community and architects to build a stunning, one-of-a kind, state-of-the-art venue, one of the best in the country and world where we showcase our local talent and help grow their following and their creative output until their careers become widely recognized and they become a symbol of our culture and drive an industry for decades to come. We could make it a sacred place, not a corporatized space. Like Pioneer Square is our living room, Waterfront Park is our front yard, our venue could be our temple. The place we showcase and venerate our artists.

In the year leading up to my album release in June 2023, I spent about \$30,000 in the Portland music industry. About \$5,000 of that was a grant from Music Portland. The rest was my hard-earned income from work outside music. This money was all spent locally in studios, on players,

graphic designers, videographers, photographers, stylists, make-up artists, gear, sound engineers, mastering engineers, vintage clothing. I am not the only artist investing in our music industry. We are hard-working, talented, passionate and over-looked. We are already spending non-music income in the local music industry because our products, the music itself, is no longer a source of significant income for us, the majority of our music-income is from performances. What will happen to us when we can no longer find a place to play in our own city? If we don't have the opportunity to develop our sounds with our fans. When Live Nation shuts us out of our home market while they parade their own artists through our town?

If you aren't catching a show in this city once a week, I could understand that you are not aware of the extraordinary quality and breadth of the Portland music industry. I've been playing stages here since 2008, so let me report back to you, we are on the verge of something big. Now is the time to invest in the Portland music industry and bring more fans to our shows so we may have a chance to build our careers and continue spending our money here and one or many of us may have a chance to make the name for ourselves that will put a stamp on our city.

Don't miss this chance to involve your citizens and artists in something that could make history and be your legacy. Inviting Live nation in to lay waste to our cultural equity that generations of Portlanders have worked hard to create is not the way forward. We are better than this. We can be the exception, let us be the "weird" one in the country. The only major city to not have a Live Nation venue. Let us continue building our unique and valuable Portland culture. Let the public benefit from our investment in the local music industry.

Hello, Prosper Portland Commissioners,

My name is Kim Gumbel. I am a musician manager and arts consultant who supports artists and performing arts organizations here in Portland. I am writing because I am worried about the future of the vital artistic community that I moved to Portland 11 years ago to join.

I am in opposition to Report 24-26, Resolution 7578, and Resolution 7579 regarding the proposed sale of land known as the "ODOT Blocks," specifically Block B, for the development of a music venue by BEAM and Colas for Live Nation.

I have serious concerns about BEAM and Colas' choice of Live Nation as a partner. Live Nation is currently being sued by the US Department of Justice and 40 US States (including Oregon) for violating antitrust laws and has consistently violated lease agreements and consent decrees throughout the United States. They have been cited for unfair and illegal business practices in cities nationwide. Last month, Live Nation violated its agreements with the City of Portland during the live performances at Providence Park. Portland is known worldwide for its culture of local businesses and creative community. Given Live Nation's actions in other cities, I am concerned that the impacts on our independent venues, artists, and arts non-profits who are just recovering from the pandemic could be detrimental. Granting Live Nation, a corporate juggernaut, control over this public land is highly unlikely to benefit Portland's creative community in the long term and contradicts the goals of responsible and ethical development in the short term.

The urgency of this sale is alarming. The potential impacts of this development deserve transparency, thorough examination, and open dialogue with all parties who will be affected. I urge you to vote against the sale of this public land and honor the intentions made in the 2017 RFP to prioritize the needs of our community over the interests of a private entity with a questionable commitment to the public good.

Dear Prosper Portland Board of Commissioners,

I write to you with deep concern for our local music ecosystem and everyone involved in it. I respectfully urge you to delay the decision on the proposed sale of public land for a Live Nation-owned and operated music venue.

My name is Cheri Jamison, and I have spent the past two years as an independent arts and nonprofit consultant in the Portland metro area. In early 2023, MusicPortland hired me to help lead the Oregon Music Census, a project initiated by the Oregon State Legislature. We partnered with Business Oregon and the Northwest Economic Research Center at Portland State University to conduct this landmark economic impact study. The study revealed that commercial music contributes \$3.8 billion to Oregon's economy, with over 75% of that impact concentrated in Portland. Commercial music and live performance have now been recognized as emerging industries in Oregon.

Following the census, I joined MusicPortland's Music Policy Council as a volunteer. Over the past two years, I have closely observed the developments regarding the proposed Live Nation venue in the Central Eastside. Recently, I was appointed Executive Director of the Alberta Abbey, a nonprofit, independent performing arts venue in NE Portland. From my experience both as a consultant and in my new leadership role, I know firsthand that artists, nonprofits, and independent venue owners—both for-profit and nonprofit—are all struggling to survive. Despite the sector still recovering from the disruption of the COVID-19 pandemic, Portland's independent music scene remains a significant economic force.

We need support, not a Live Nation venue.

Our opposition is not directed at the developers but specifically at Live Nation/Ticketmaster, a company with a well-documented history of unfair business practices. The U.S. Department of Justice and 40 states, including Oregon, are currently suing Live Nation for antitrust violations. Live Nation's monopolistic behavior is a threat to independent music culture.

As you consider this decision—whether the extended lease or sale of the land to the developers—you must take into account Live Nation's involvement. The Portland music community has been raising the alarm, and we urgently ask that you listen.

I respectfully request that you delay the decision on this public land sale. There has not been enough public notice or input regarding a decision that will profoundly impact an entire industry.

For the record, my name is Meara McLaughlin, I live at 2332 NE Wasco St in Portland. I co-founded MusicPortland in 2018, where I currently serve as Executive Director. MusicPortland is the first nonprofit trade association dedicated to representing the economic interests of Oregon's commercial music sector. For nearly seven years, alongside a committed team of volunteers, I have worked to unite, assess, and advocate for this sector as a vital economic and cultural force within our city and state.

Despite media reports that often minimize our opposition to Live Nation as simply coming from 'a group of local musicians,' MusicPortland represents over 700 Portland-area music businesses. With enterprises ranging from CD Baby to audio production companies, instrument and gear manufacturers, record labels and more. We are the united voice of this complex local ecosystem. We also represent over 9,000 unique and active Portland based recording acts (according to CD Baby) and more music-hosting spaces than Nashville or Austin.

The most vulnerable to Live Nation's market dominance are Portland's 50 dedicated music venues and over 200 mixed-use venues that host live music regularly. It is striking that none of these respected local venues have publicly supported our campaign. Their silence is a powerful indicator of the control that Live Nation holds over this creative economy. In other cities, Live Nation's practices have included closing independent venues that compete or 'offend'—as noted in the DOJ lawsuit. Here in Portland, I have spoken to mdozens of venue owners of all sizes who privately support our efforts, but fear retaliation if they speak out.

This culture of fear does not foster a healthy business environment. It should not be allowed to take root, nor should it be encouraged with unearned advantages —especially by those entrusted with fostering local entrepreneurship and economic growth.

As you well know, not all development is equal. Who controls the resources that are created matters. This development represents powerful money buying access to public resources to give themselves leverage to take over a market sector. What makes it worse is that it is not just a local business sector that is endangered, but the heart of our cultural and civic identity.

Please do not commit to sale of this property on this unprecedented fast track. If this is a good deal for Portland, then it will hold up in the light of scrutiny and time for public opinion.

For the record, my name is Marshall Runkel, I work for Strategies 360, my address is 1001 SE Water Ave, Suite 350. I represent Monqui Presents, a Portland company that likes to say it has been importing fine live music since 1983. Thank you for the opportunity to testify today.

First, I'd like to say that it's difficult to be here to voice opposition when Director Branam is being recognized for her years of service to our city, with Prosper staff whom I respect and admire as well as representatives from Beam, Colas and other community organizations that are pillars of our community. I hope that you will receive my testimony in the constructive spirit that I intend it and recognize that only a dire threat like the one posed by Live Nation would motivate me to oppose the proposed land sale today.

It is easy to understand why Proper Portland would pursue the project when it became clear that the development concept that led to the award of the property to the Beam team was no longer viable. It was universally understood that Portland needed a venue of the size and type that was being proposed. No other similar project was being considered and the US Department of Justice and 40 states, including Oregon, had not sued Live Nation/Ticketmaster for its anti-competitive behavior.

Since then, the situation has changed. My clients are moving forward with a better project in a much better location for music fans and for the City of Portland. The US Department of Justice and 40 states, including Oregon, have sued Live Nation/Ticketmaster. US Attorney General Merrick B. Garland said, "We allege that Live Nation relies on unlawful, anticompetitive conduct to exercise its monopolistic control over the live events industry in the United States at the cost of fans, artists, smaller promoters, and venue operators. The result is that fans pay more in fees, artists have fewer opportunities to play concerts, smaller promoters get squeezed out, and venues have fewer real choices for ticketing services."

Prosper Portland's obligation to the citizens of Portland regarding the disposition if public land also changed. The new plan to sell the property to construct a venue for Live Nation/Ticketmaster does not remotely resemble the concept that prevailed in the official procurement process for the development rights for the site. If Prosper Portland conducted a proper public process, it would learn what I have over the course of the last several weeks, people in Portland are not interested in selling their land for a Live Nation venue.

The About Us section of Prosper Portland's web site includes the following, "We work with partners to drive public attention and resources to different areas of the city, which helps

Portland realize capital projects – parks, streetscape improvements, community centers – that would not happen on their own, making it a better place to live for all Portlanders." The key phrase in that statement is "would not happen on their own." That concept is the heart of reason for Prosper Portland existing. In this case, another project is happening on its own. And it's happening in an area that has much more immediate and long-term potential for the kind of tax base growth that is integral to Prosper Portland's mission than the site you are considering today.

The last point I'll make about how the project is not in alignment with Prosper Portland's stated values and strategies is that dedicating the proceeds of the sale of the property to local businesses as well as the benefits to the local companies that would develop and build the project will be far outweighed, according to evidence compiled by the US Department of Justice, by the damage that Live Nation will do to local businesses. Adequate public process, when it works best, provides a means to analyze and assess these kind of difficult tradeoffs.

In the spirit of not only offering a problem, but also potential solutions. I believe there are a number of creative, profitable uses for the site that can and should be pursued immediately instead of a Live Nation/Ticketmaster venue. It would be a great site to work with representatives of the people that have inhabited the area for at least 10,000 years before European and other immigrants arrived. Perhaps it could be the site of the first gaming facility in the City of Portland and/or public market like Pike Place market that honors and recognizes the neighborhoods historic role as a food distribution hub and/or an aquatic facility that provides opportunities for Portlanders and visitors to rent boats, go swimming and learn about the natural and current history of the area?

As has been noted, the site is where the Mt Hood Freeway would have connected with 15. When Portlanders said no to the Mt Hood Freeway, they said yes to the first leg of the light rail system. A similar pivot is available with this project, it should be a win/win situation for our community.

For the record my name is Philip Graham and my address is 2332 NE Wasco St, Portland.

I own a small company employing five people in Northeast Portland manufacturing microphones that are used by musicians worldwide. Our customers include multiple Grammy winners, but more important to us are the working, touring, independent artists and the independent venues that form the backbone of the local and national music ecology.

Our business likely could not have started and prospered anywhere but Portland, with its culture of craft manufacturing but more importantly its vigorous, creative, experimental, and welcoming independent music ecosystem.

In working with artists all over the country, I have come to recognize just what a rare and precious commodity our music ecosystem is. In city after city, venues of all sizes are becoming a monoculture. Their treasured cultural icons, which form the backbone of local music scenes, have been forced to either close or sell out to LiveNation. One company controls the majority of performance spaces, prioritizing their own national roster of artists at the expense of local acts. They convert money once spent in local businesses to profit for a multinational corporation's owners. They make music more expensive with ticket fees, pay artists less, and pay their workers less. That's what you do when you control a market. They reach this position of dominance by leveraging their control of ticketing, artist management, and restrictive clauses on booking at the hundreds of venues they already own, exercising coercive control over so much of the national touring industry that they can force any individual venue into either closing or selling.

I am writing to express my concerns with Live Nation's proposal to open a music venue on Water Avenue near the Hawthorne Bridge. Our local independent music scene is a vital part of Portland's unique cultural fabric, and this proposal potentially threatens its very existence.

As you consider the impacts to infrastructure, it's important to highlight the broader concerns that we have as Portlanders. The community has zero confidence this venue will serve the public good without imposing significant risks. To whom it may concern,

LiveNation has no place owning a venue on what is currently public land in a city like Portland. from a U.S. Department of Justice (DOJ) lawsuit filed in April 2024. The DOJ accuses Live Nation, which merged with Ticketmaster in 2010, of abusing its dominant market position to stifle competition and inflate ticket prices.

The allegations are two-pronged. First, the DOJ claims Live Nation uses its control over concert venues to pressure artists into using Ticketmaster exclusively. This shuts out competing ticketing platforms, limiting consumer choice. Second, the lawsuit alleges Live Nation leverages its size and dominance to impose unfair fees and restrictive terms on artists and fans alike.

The DOJ alleges that Live Nation's anti-competitive practices exercise "monopolistic control over the live events industry in the United States at the cost of fans, artists, smaller promoters and venue operators," Attorney General Merrick B. Garland wrote in a release by the DOJ.

The company that books Mississippi Studios, True West, also books Pioneer Courthouse Square and Revolution Hall (the LiveNation venue is supposedly able to scale shows down to about the capacity of Rev Hall). They also book Polaris Hall, Show Bar, and Aladdin Theater.

If a local promoter/venue operator like True West isn't able to secure the strongest shows in their largest venues, the loss of revenue will effect their venues downstream and affect their ability to support their smaller spaces.

Likewise, will Edgefield be able to compete? That'd effect Crystal Ballroom Mission Theater, White Eagle, and Al's Den. It'd also effect Monqui presents, who does all the Edgefield booking, which would likely impact Wonder Ballroom, and their plans to reopen Doug Fir in the old Montage space.

Or even Pickathon! Will they be able to secure strong headliners against exclusivity and radius agreements that the LiveNation venue will insist the artists they book sign? Well, that could effect Star Theater, Dante's, and the Showdown.

But not only does it negatively impact that local promoter/venue operator, it'd effect the local ticketing companies they work with. If True West isn't getting as many big, good selling shows for Pioneer Courthouse Square, will Cascade Tickets/Etix be able to keep collecting enough service fees to stay in business? Will all the small and mid-size venues have to switch to Ticketmaster? Service fees suck no matter who is collecting them, but no one is charging quite as much as Ticketmaster.

These are all valid concerns. Please reconsider.
