Chair Cruz thanked Ms. Hanson for her comments, and Executive Director Flaherty Betin connected her with staff on site who could connect her to technical assistance providers.

#### **REGULAR AGENDA**

 Action Item: Resolution 7594 - Approving the Terms of a Commercial Property Loan to Future Stack, LLC, in an Amount Not to Exceed \$7,000,000 for Acquisition and Improvement of Two Commercial Buildings at 208 NW 5th Avenue and 234 NW 5th Avenue

With this action, the Board authorized the Executive Director to enter into an agreement to make a Commercial Property Loan, with exceptions (Loan), to Future Stack, LLC, DBA Made in Old Town (Borrower) in an amount of up to \$7,000,000, at an interest rate of three percent, for acquisition and improvement of commercial space located at 208 and 234 NW 5th Avenue (Property).

The Borrower intends to use Loan proceeds to acquire the Property and pay for other project related costs as part of a broader vision to create a campus that includes design, research, studio, office, and manufacturing facilities serving the footwear and apparel industry (Made in Old Town, or Project).

Ms. King provided an overview of the Project and proposed Commercial Property Loan to Future Stack, LLC, DBA Made in Old Town and stated the project costs were part of a broader vision to create a campus that includes design, research, studio, office, and manufacturing facilities serving the footwear and apparel industry.

Ms. King highlighted the strategic alignment via several Advance Portland, specifically by propelling inclusive economic growth and innovation (Objective 1, Action 1.2.3), including increasing



commercialization of research and development; fostering a vibrant central city and commercial districts (Objective 3, Actions 2 & 6), by retaining and increasing commercial activity and support small businesses in the Central City, and activating vacant properties with community serving businesses; and by connecting Portlanders to high quality jobs in future-ready sectors (Objective 4, Action 3.4), through locating major economic investments and target business growth near underserved areas.

Ms. King also highlighted alignment with the Old Town/Chinatown Action Plan, including attracting new neighborhood investment to activate key properties and improve district connectivity, as well as the potential to create well-paying jobs, facilitate design internships, and host competitions and events.

The Property includes 208 NW 5<sup>th</sup> Avenue, a two-story warehouse building, and 234 NW 5<sup>th</sup> Avenue, a seven-story building. Combined, the two vacant buildings include approximately 98,000 square feet of rentable area. The Loan borrower is Future Stack, LLC (Borrower), DBA "Made in Old Town." The Borrower's sole member is the Old Town Perpetual Purpose Trust, which is managed by Trustors Matthew Claudel, Jonathan Cohen, and Elias Stahl, with Greg Bui serving as Trustee.

The Old Town Chinatown Community Association Board has expressed support for the Project and an investment of Prosper Portland's Action Plan resources.

Mr. Novelo provided information on the Borrower, the appraisal, and the loan terms. He reviewed the exemptions to Prosper Portland's program guidelines due to the high impact of the project. Chair Cruz invited the Borrowers to speak.

Matthew Claudel, Jonathan Cohen, and Elias Stahl spoke about their vision for what the Project could become, intended to foster innovation and efficiencies by concentrating talent and suppliers in proximity, and by accelerating on-premises sample-making, instead of depending on the offshore supply chain. The campus provides access to world-class equipment and a deep talent pool across brands, suppliers, and innovators, enabling them to make the next generation of footwear and apparel.

Chair Cruz invited discussion and questions from the Board.

Commissioner Alvarez acknowledged the scale of ambitious vision and expressed hope that it inspires others to bring the city together.

Commissioner Slick echoed hope that other efforts will come out of this project, and expressed gratitude for the work the team has out into an effort driven entirely by the community.

Commissioner Hagins requested additional detail regarding their tradeshow model, rotating space and turnover, including length of lease. Hagins also asked questions about their State funding request, and the Borrowers replied that they hope the funds will come from an existing program rather than another legislative appropriation.

Commissioner Stoudamire Wesley asked questions about inclusion of both the footwear and apparel industries and encouraged the borrowers to focus on local start-ups.

Chair Cruz echoed the enthusiasm of the rest of the Board but asked to drill down on the terms of the deal. He requested information on the structure of the trust and how it functions. He also inquired about the pricing of the building itself, competing interest in the property, and alternative uses for the current state of the properties (e.g., conversion to housing). He requested information on the financing gap and alternative financing plans.

Chair Cruz called for a motion to approve Resolutions No. 7594, Commissioner Alvarez moved, and Commissioner Slick seconded the motion.
